1 Introduction

Edinburgh values its reputation as one of the most beautiful cities in Europe, renowned for its setting, history and built heritage. Parks and greenspaces are integral to this. They serve as a stage for our public lives and are settings where celebrations are held, where social exchanges take place, where friends mix, where cultures run into each other, where nature thrives, and where people revive themselves from the stresses of urban living.

The Parks and Greenspace Service is committed to providing quality parks for residents and visitors alike. There are five qualities that make a park great, and that drive the work of the Parks and Greenspace Service: They must be full of activity and invite affection. They must also be visible and accessible as well as being comfortable and safe. They also need to be places you can count on, no matter if you visit the park every day or once a year.

Using the Green Flag judging criteria all of Edinburgh's parks are assessed on an annual basis and a Parks Quality Score is produced for each site. These scores are compared to the Edinburgh Minimum Standard which has been developed to benchmark our parks and record how they are improving.

In Edinburgh the involvement of local residents through a network of Friends groups is well established. Depending on their capacity, sites host both major and local events and activities, offering a wide range of attractions to families and individuals from a diverse community.

The Parks and Greenspace Service ensures that Edinburgh's parks and greenspaces are clean, safe, colourful and diverse; they will be the setting for activities and celebrations; be well-known for their features, history and "happenings"; and be locally valued and used.

To this end our vision is:

"A quality parks system worthy of international comparison; accessible, diverse and environmentally rich; which fulfils the cultural, social and recreational needs of the people".

2 Methodology

2.1 Green Flag

The Green Flag Award is the national standard for parks and green spaces. The award scheme began in 1996 as a means of recognising and rewarding the best green spaces in the country. It was also seen as a way of encouraging others to achieve the same high environmental standards, creating a benchmark of excellence in recreational green areas.



2.2 Criteria used

Whilst the Green Flag Award contains both desk and field research, this project was limited to site based assessments carried out by Council officers, external partners and members of the community trained in assessing parks using Green Flag criteria. Thus the final 'Parks Quality Score' (PQS) should not be read as the site's score against the Green Flag Award but should be used for indicative purposes only.

Although some criteria are difficult to assess during a field visit, the Green Flag Forum evaluated certain criteria in a desktop exercise and provided guidance for allocating scores. Site managers are asked to score the 'desktop' criteria on an annual basis.

Listed below are the criteria that were used in the quality assessments:

A Welcoming Park

- Welcoming
- Good and safe access
- Signage
- Equal access for all

Healthy, Safe and Secure

- Safe equipment facilities
- Personal security in park
- Dog fouling
- Appropriate provision of facilities
- Quality of facilities

Clean and Well Maintained

- Litter and waste management
- Grounds maintenance and horticulture
- Buildings and infrastructure maintenance
- Equipment maintenance

Sustainability

- Environmental sustainability energy and natural resource conservation, pollution (*Desktop Assessment*)
- Pesticides (Desktop Assessment)
- Peat use (*Desktop Assessment*)
- Waste minimisation (Desktop Assessment)
- Arboriculture and oodland management

Conservation and Heritage

- Conservation of natural features, wild fauna and flora
- Conservation of landscape features (*Desktop Assessment*)
- Conservation of buildings and structures

Community Involvement

- Appropriate provision for the community (*Desktop Assessment*)
- Community involvement in management and development including outreach work (*Desktop Assessment*)

Marketing

- Marketing and promotion (*Desktop Assessment*)
- Provision of appropriate information
- Provision of appropriate educational interpretation/information

• Implementation of the management plan

2.3 Scoring of Criteria

Each individual criterion was scored out of 10. Criteria that did not apply to a particular site – e.g. 'conservation of buildings or structures' on a site where no buildings or structures are present – were scored as not applicable and were therefore not included in the total score or average calculations.

The Parks & Greenspace Forum agreed to use the scoring system below to assess their sites.

2.4 Park Quality Score

Park quality scores were obtained by adding together all the criteria scores and dividing the total by the number of applicable criteria resulting in an average score. This score is then multiplied by 100 to obtain a Park Quality Score (PQS). The maximum score available was therefore 100% for each site.

2.5 Variance

In an attempt to ensure that a consistent and accurate score for each site was achieved, assessment teams are led by an experienced officer who in most cases is also a formal Green Flag Award judge. There was also additional guidance included in the assessment documentation. Scores and comments from the previous year's assessment, along with improvements carried out over the last 12 months were also provided to assessors so as to provide a starting point, with improvements and deterioration in quality reflected in the scoring.

Each site was assessed once by a team of assessors.

2.6 Bandwidth Scoring

The system used in 2009 saw the introduction of bandwidths. This was to accommodate the natural variance of assessors both in terms of reliability and repeatability. The accepted variance of 10% meant that the forum opted for bandwidths instead of a % score. The forum went one step further and instead of simply creating a bandwidth for scores out of 100%, they looked at each type of park and allocated bandwidths based on the expected quality and appropriateness of each type of site.

In addition to the bandwidths it was agreed that there should be a minimum level of quality for each type of park and as a result the Edinburgh Minimum Standard was set at the 'Good' bandwidth for most park types. The exceptions were Premier Parks and Natural Parks where it was argued that the sites could be judged as good even though they did not meet the Minimum Standard score and it was agreed to introduce a 'Good+' bandwidth for these two classifications to show where the standard was met.

The table below shows the park classifications and bandwidths agreed.

2.7 Sites

Due to the reinstatement of Atholl Crescent and Coates Crecent following Tram works it was agreed that again these sites would <u>not</u> be assessed in 2015. Buttercup Farm park is a newly created park in the West of the city and has been added to the assessment list for 2015.

In 2010, as part of the Open Space Strategy and to ensure that Edinburgh complied with the Green Flag Authority Group Award approach (see section 6.1) to assess all accessible green spaces, it was decided that Cemeteries should be assessed using the Green Flag criteria. Assessments were undertaken of 32 cemeteries in 2010, 2011 and 2012. A proposal was made in 2013 that Cemeteries would no longer be assessed due to the unchanging nature of many of the sites, unless specific sites are identified for improvement or Green Flag Award but would not form part of any area calculations.

In total 138 sites were identified to be assessed in 2015.

2.8 Assessors

This year saw 14 teams undertake the assessments between April and July. Each team was made up from an experienced lead officer (in most cases a formal Green Flag judge) with up to four assistant assessors. Assistants were made up from Council officers and members of the community.

Awareness of the Green Flag scheme and guidance on scoring criteria was provided for all new assessors.

In total 53 assessors were used to carry out this year's assessments and since 2008, 136 assessors have taken part with many being involved for two or more years.









5.4 Results Summary

Bandwidths

This year well over two thirds of Edinburgh's parks were judged as 'Excellent' or 'Very Good' and a quarter as 'Good'. In total 96% were deemed 'Good' or better leaving only 6 parks out of 138 ranked as 'Fair' and none as 'Poor'.

The results also showed that 29 parks moved up in bandwidth in 2015, seven more than last year whilst only 11 dropped compared to 18 in 2014.

The South West Neighbourhood had the biggest number of parks improving (8) whilst the West and South were only one behind at seven. The South saw all but one of their parks in the 'Very Good' or 'Excellent' bandwidths.

Park Quality Scores

Although bandwidths reflect a more accurate description of a parks quality, by taking into account the natural and accepted variance of judges scoring and that certain aspects of parks can change on a day to day basis, it can be interesting to explore a little deeper into the Park Quality Scores.

It is noted that nearly two thirds (86) of Edinburgh's parks improved on last year's score whilst 37 deteriorated. The South West (21) and West (20) Neighbourhoods have the biggest number of parks that improved.

The citywide average parks quality score continues to improve year on year and parks have now improved from 49% in 2008 to 62% in 2015.

Over half of Edinburgh's parks now score highly enough to indicate a Green Flag Award Field Assessment Pass would be likely.

Some Individual sites also showed considerable increases from last year with Pike's Pool (+13% to 55%) and Starbank Park (+10% to 73%). This year also saw Pentland Hills Regional Park equal the highest ever score of 81% set in 2008 by Princes Street Gardens. It is also worth recognising however that out of the 10 lowest ranked sites six dropped in score and efforts should be made to ensure these parks don't drop into the 'Poor' bandwidth.

Edinburgh Minimum Standard


Following last year's results, the 2015 target for sites meeting the Edinburgh Minimum Standard was set at 92%, an increase of 1% on last year's target and was agreed, following discussion, to reflect the desire to continue improving the quality of our parks whilst recognising that challenges lay ahead.


It was pleasing to note that all Neighbourhoods increased the number of parks meeting the Edinburgh Minimum Standard in 2015 with the exception of South who for the second year running ensured that 100% of their parks exceeded the mark. It was also noted that all but one of the Neighbourhoods met the 2015 target of 92%.

With only 56% of parks meeting the Edinburgh Minimum Standard in 2008 the 2015 results show that we now have 130 out of 138 parks (94%) meeting the grade.

Criteria Score Averages

Citywide, 21 out of 26 average criteria scores improved from 2014. The biggest improvers were Litter Management and Grounds Maintenance whilst Information Provision was the only criterion that dropped.






5.7 Site Improvements & Recommendations

Improvements since last year


Prior to this year's assessments, site mangers were asked to provide an update with regards to improvement that had taken place in their parks since the last PQA assessment. Each improvement was then aligned to one Green Flag criterion resulting in the ability to provide an overview as to where improvements had being targeted across the City.

The chart below shows the number of actions for each of the criteria.



Judges recommendations

Following the park assessments, judges were asked to provide recommendations that, based on their findings, would improve the quality of the site. These recommendations were linked to one criterion so as to provide an overview of where judges think improvements should be focused. The chart below shows the number of recommendations for each of the criteria across all parks.



5.8 Park Improvement & Management Plans

Improvement actions can be identified for parks through various sources i.e. user surveys etc and the Park Quality Assessments carried out each year provides the site manager with additional specific information on the quality of their parks that can be used to identify areas for improvement or promotion. There is also information available following the publication of the PQA report that allows managers to identify targeted improvements across Neighbourhood Areas or the City i.e. dog fouling campaigns.

It is hoped that managers use all the available information including the judge's recommendations to create an annual Park Improvement Plan that can be recorded and updated to evidence improvement. This is especially important where the site is a current Green Flag Award park and the improvement plan forms part of the management plan.

5.9 Green Flag Forum

The Green Flag Forum will convene towards the end of year to discuss the results and agree strategic objectives that should lead to improvements in both area and citywide sites.

6 Green Flag Awards

Green Flag Awards are a way of recognising sites of quality. The awards are provided on an annual basis and each site must re-submit their application each year to retain the award. The scheme also involves a Green Flag Community Award (formerly Green Pennant) which is to reward sites that are managed by the community.



In 2007, the scheme was trialled in Scotland with Edinburgh taking part along with Dundee. In that year Edinburgh was successful in achieving two Green Flags (Braidburn Valley Park and Harrison Park). The total rose to three in 2008, and five in 2009, that year also saw the first Green Pennant in Scotland awarded to Corstorphine Walled Garden. In 2010, Edinburgh was awarded a further eight Green Flags bringing the total to 13 plus Corstorphine Walled Garden retained their Community Award.

In 2011 Edinburgh was included in the pilot of the Green Flag Group Award Scheme and as a result all Edinburgh's existing Green Flag Award winning sites were automatically awarded Green Flags when the standard was maintained following self assessment. In addition to this a further seven new sites were successful in 2011, four in 2012 and two in 2014.

In 2015, Edinburgh added three new sites (Ferniehill Community Park, Rosefield Park and Starbank Park) bringing the total Green Flag Award winning parks in Edinburgh up to 29 plus one Green Flag Community Award.

6.1 Green Flag Group Award

In 2011, Edinburgh was invited to take part in the pilot of the Green Flag Group Award that saw two peer judges assess the strategy the authority has to managing its greenspaces every two years and assesses the risk of the authority failing to maintain its Green Flag Award parks to the required standard. The judges pay particular attention on how Green Flag has been adopted into the various strategies, through self assessing its entire stock using the Green Flag criteria and how it uses the information to improve, not only the Green Flag Award winning sites but all sites across the authority.

The last assessment in 2014 resulted in a successful 'Low Risk' result with judges highlighting Community Involvement, the Park Quality Assessment process and Lansdcape Quality Standards as strengths.

Following the self assessments, Green Flag Award winning sites in 2014 can be awarded a Green Flag Award for 2015 by the authority themselves if the standard is still maintained. However, these sites will be subject to one or more mystery shopper assessments at any time during the next twelve months which will see an external Green Flag judge arriving at the park unannounced and assessing the site based on a visitor experience.

As part of the PQA assessments, judges are asked to report any major issues found whilst undertaking assessments to the site manager. For Green Flag Award parks, this reporting is extended when judges encounter any issues that fall below expected Green Flag quality. This approach ensures managers are aware of issues affecting Green Flag parks and acts as a early warning for sites that are subject to mystery shop assessments as part of the Green Flag scheme.

New sites identified for the award will continue to be assessed using the existing judging method of two judges assessing the management plan and undertaking a formal site visit.
























Park Quality Scores Trend





Improvements since last year

Prior to this year's assessments, site mangers were asked to provide an update with regards to improvement that had taken place in their parks since the last PQA assessment. Each improvement was then aligned to one criterion resulting in the ability to provide an overview as to where improvements were targeted across the Neighbourhood.



Judges recommendations

7.11 Desktop Criteria Scoring Guidance

Listed below is the guidance and scoring used in assessing desktop criteria.

Environmental Sustainability

Here is the reasoning for a general citywide environmental score of 6 out of 10, however site managers can adjust this score if sustaianable practices have been implemented on site.

Un-metered electricity use (which will include street lighting and Christmas lights in park) has essentially flat lined over the past three years but there has been a slight decline over the period, we are monitoring usage and street lighting and is including within the scope of the Council's Carbon Management Plan.

The city has a number of Air Quality Management Areas and these will cover city centre parks. However, we are actively seeking to redress our air quality problems through our Air Quality Action Plan

We have a Green Fleet Policy which applies to all Council vehicles active in park management and a number of specific initiatives e.g. electric scooters for environmental wardens have been brought forward in recent years;

In terms of water, an extensive programme of water repairs and metering in parks was taken forward a few years ago as part of a Council-wide Water management Project

Some parks may occasionally suffer from or be the source of noise pollution. However, an extensive programme of citywide noise mapping has been completed and a Noise Action Plan has been prepared by the Council and its partners

Pesticides

A policy needs to be developed that considers the minimisation of herbicide use. Meanwhile herbicide application is only used when cultural practises will not provide adequate control. Only affected areas are treated and only then using strategies that are sensitive to the needs of the public and the environment. All operatives are trained to the approved certification level for the application of chemicals. The application of herbicides is scheduled during off-peak times of park use and signs are posted to indicate the re-entry time period if appropriate. It was agreed that a score of 10 out of 10 for natural sites and 4 out of 10 for others would be recorded unless site managers proposed a new score accompanied with evidence.

Peat Use

The only use of peat by the Parks and Greenspace Service is in the production of bedding plants at the Council's Inch Nursery. Since 2004 the nursery has reduced it's consumption of peat by 25% and aims to meet national targets of 90% by 2010. A number of alternatives to peat have been incorporated into the growing mixes for plant production at the nursery, including; compost derived from the Council green waste collections, the nursery own compost, worm cast, fine bark, vermiculite and sand. Trials have been run since 2007 to assess the best mix to support seedling and plant growth. It was agreed that a score of 7 should apply where bedding is used in a site and where no peat is used a score of 10.

Waste Minimisation

It was agreed that a corporate score of 2 out of 10 would apply to all sites for 2009. This is perhaps unfair to those sites that do attempt to manage their waste so it would be relevant for each site to be judged independently. Each site should be judged considering the following:

- Does the park have on site recycling facilities for litter
- Does the park have on site composting/recycling facilities for greenwaste
- Following maintenance operations is green waste disposed of on site. N.b It should not be deemed 'good' if the site has no greenwaste to dispose of through lack of maintenance operations, please score on the basis of what would happen if the operations were carried out.

Scoring

- 7-10 Waste is sorted on site and <u>all</u> green waste is recycled/composted
- 5-7 Waste is sorted on site and some green waste is recycled/composted
- 5-7 Waste is not sorted on site but <u>all</u> green waste is recycled/composted
- 3-5 Waste is not sorted but <u>some</u> green waste is recycled/composted
- 1-2 Waste is not sorted and green waste is not recycled/composted

Conservation of Landscape

The following table was used to judge the Conservation of Landscape for each site:

Where landscapes have been established as being important for historical reasons and / or design reasons they should be conserved as far as possible. The whole park should evidence the historic design relationship between buildings and built features, woods, trees in groups and single specimens, shrubberies and planting beds, open areas, water bodies, circulation routes and important view lines.

Each site should be judged by asking the following questions:

- Has the site been designated an area of natural or historical interest?
- Do important views and vistas still exist?
- Do the style and standard of horticultural displays harmonise with the sites historic character?
- Are efforts made to provide for continuity in historic collections of trees and shrubs?
- Are efforts made to retain or replace ornamental detailing on historic features?
- Do new or replacement features conserve or enhance the sites historic character?

Scoring

- 9: If the answers to applicable questions are YES and the site has been designated as one of historical interest.
- 7: If most of the answers to applicable questions are YES
- 5: If some of the answers to applicable questions are YES
- 2: If none of the answers to applicable questions are YES
- 1: If none of the answers to applicable questions are YES and the site has a designation.
- 0: Not Applicable to site

Community Involvement

The following scale was used to judge the involvement of each site:

- 9-10: Very active in running the park
- 8: Active, lots of events, fundraising etc
- 7: Good, some events
- 6: Fair, group in place, hold meetings
- 5: Group exists but does little
- 4: Periodic community involvement
- 2-3: Some involvement in past (millennium planting etc)
- 1: Never been any involvement

Community Provision

A score of 6 out of 10 was awarded to every site based on the support from each of the Neighbourhoods in the form of funding, etc unless site managers proposed a new score accompanied with evidence..

Marketing

The following scale was used to judge Marketing and Promotion of each site unless site managers proposed a new score accompanied with evidence.

- 7 Countryside Ranger Site
- 7 Friends Site with regular newsletters etc
- 7 Green Flag Sites
- 4 No marketing except our own website etc
