## NOTES FOR GUIDANCE

- 1. Licences will initially last for one year. Applicants for temporary licences (maximum 28 days) should simply state the period during which they intend to operate.
- 2. The application should be lodged at least 28 days before the date from which you wish the licence to operate.
- 3. Unless the application is for a period of 28 days or less, a Site Notice must be displayed. Paragraph 2 of Schedule 1 of the Civic Government (Scotland) Act 1982 deals with advertisement of your application. A style Site Notice is attached. The notice must be displayed on or near your premises in a position where it can be easily read for at least 21 days beginning with the data on which the application was submitted to the council and you must return to the Council at the expiry of the 21 days a copy of the notice with the certificate at the foot completed.
- 4. If you are successful in obtaining a licence you will be required to keep detailed written records, including full descriptions of the types of articles (knives, swords or blades) to be sold or otherwise dealt with in terms of the licence.

5. The licensing conditions to be applied to Knife Dealer licences are the mandatory conditions as set out in The Knife Dealers (Licence Conditions) Order 2009 (SSI no. 217). The City of Edinburgh Council reserves the option to add appropriate local conditions, after due consultation and publication.
