NOTES FOR GUIDANCE

- 1. "Horse" includes mare, gelding, pony, colt, filly or stallion and also any ass, mule or jennet.
- 2. A licence may be granted only to an individual over the age of 18 years or a body or corporate. It will be a condition of any licence granted that the carrying on of the business of a riding establishment shall be at no time left in the charge of any or person under 16 years of age.
- 3. It will be a condition of any licence granted that no horse will be let out on hire for riding or used for providing instruction in riding without supervision by a responsible person of the age of 16 years or over unless (in the case of a horse let out for hire for riding) the holder of the licence is satisfied that the hirer of the horse is competent to ride without supervision.
- 4. Licence will be granted from the date of issue or 1st January in any year and will be valid to 31st December following.
