Summary of Enhancements of Rights

Depriving a child of their liberty in any form will only be imposed as a last resort and for the shortest period possible. The views of the child and their parents/carers will be obtained at the earliest opportunity and consdered as part of the Movement Restriction Condition (MRC) assessment. An MRC will not be pursued where there is not agreement from the child, parents or the carer where the child resides.

Children are not automatically provided with legal advise when a MRC is being considered by a children's hearing, it is only routinely provided when secure care is being considered. Where an MRC is being considered the child and their parent/carers will be informed of their

rights by the lead professional and will be able to seek legal advice if they choose. In addition to this children who are looked after will be entitled to support by the council's Children's Rights Team and Who Care? Scotland.
