This ERIA relates to the tender of a contact for a registered one to one day service for older people throughout Edinburgh. The procurement approach to day services for older people has been developed in line with the Commissioning Plan for Social Care Day Services for Older People 2012-17 and the Market Shaping Strategy.	August 2014
One to one day service for older people are currently provided by Life Care. European and Scottish procurement legislation requires the Council to advertise contracts for competition. The results of a soft market testing exercise in October 2014 will demonstrate if there is interest from providers in delivering the service. Should there be interest in the delivery of this service the Council will be required to formally advertise the contract for tender. This ERIA considers any impacts that the procurement process may have on the equalities and rights of services users, staff and the wider community.

Summary of Enhancements of Rights

Life

Helping people live as independently as possible for as long as possible in their own homes and communities is a key aim of Live Well in Later Life, Edinburgh's Joint Commissioning Plan for Older People 2012-22. Day services play an important role, as part of a wider range of services, in supporting people to continue living in the community, by providing socialisation, improved health and wellbeing, and providing a break for unpaid carers.

Health

Improved health and wellbeing for older people is a key outcome for all day services in the city. The service specification for registered day services for older people includes a number

of outcome measures which day service providers are required to meet.

Physical security

Feeling safe is a key quality of life outcome, included in the specification for registered day services for older people.

Legal security

Day services provide a range of support for older people which may include signposting service users to appropriate information, advice and support in relation to, financial, welfare rights and advocacy services.

Education and learning

Lifelong learning is a factor in successful ageing. Activities that can be facilitated by one to one day services include those which focus on keeping mentally active. Day services also have a role in encouraging service users to remain connected to community activities and resources which may be through classes, library resources or adult education courses.

Standard of living

Registered one to one day services provide personal care for service users that require it. This may include washing and showering. These services have an important role in the standard of living for frail, older people living in the community. Signposting to welfare advise services and providing a break for unpaid carers, who can often be under considerable stress, all contribute to improved standards of living.

Productive and valued activities

One to one day services provide an important opportunity for service users to take part in a range of productive and valued activities. Providers are required to demonstrate the provision of meaningful physical and cognitive activities, tailored to individuals, and to facilitate activities based on outcomes and wished identified from service users.

Individual, family and social life

The provision of one to one day services is intended to ensure that people who have care and support needs and wish to continue living in their own home or community are supported to do so. Social isolation can be a reason why a person may wish to consider alternatives to remaining at home therefore one to one day services promote these rights. The value of family connections in older age has been identified within research studies however it has also been recognised that some older people do not have family members on whom they can rely. One to one day services provide an important opportunity for isolated older people to continue to maintain social networks or activities they have previously had interest in.

Identity, expression and self-respect

Provision of a personalised service, based on individual choice, is central to the service specification for registered one to one day services.

Extract from service specification:

Successful delivery of the service involves putting the person at the centre of decisions about the way they want to live and the support they want to receive. It requires that services are provided in a way which reflects a strong commitment to the principles set out in the National Care Standards. The principles are dignity, privacy, choice, safety, realising potential and equality and diversity. It also requires close co-operation with and listening to the views of people who use the service and where appropriate, family carers and friends.

Participation, influence and voice

Registered day service providers are required to ensure that people contribute to and are fully involved in the development and regular review of their Personal Plan, have a variety of opportunities to express their views on the service and are actively involved in the development of the services – for example through one to one conversations, reviews of service and outcomes or questionnaires.

Summary of Infringement of Rights

This ERIA relates to the tender of a contact for a registered one to one day service for older people. The process may result in a change in provider for the service. The quality of service provision and the protection of the rights of service users is a key priority throughout the procurement process. The following actions have been taken to ensure that these priorities are met:

• A robust service specification has been developed for the service, with a focus on the rights of service users and quality standards

• The service is required to be registered with the Care Inspectorate and as such will be required to adhere to registration requirements

• The evaluation of tender bids will be carried out in a way that aims to ensure that quality standards are maintained, this includes;

- application of a 'quality : cost' weighting

- evaluation questions cover key areas of the service in relation to quality of service, equalities and rights

- a robust evaluation process undertaken by staff with appropriate experience of older people's health and social care services

- a communications plan will be developed and will be implemented in partnership with the current provider to ensure that key messages are communicated to relevant stakeholder in a timely and appropriate manner

- If the result of the tender means that the contract is awarded to another provider, transition arrangements will be well planned to ensure minimum disruption for service users.

Positive Impacts

All day services for older people are required to "take positive action to combat discrimination and identify individual needs arising from specific ethnic, religious, cultural, gender, sexuality, disability or age requirements and ensure their staff are able to meet these needs" (extract from service specification).

Age - Registered one to one day services provide support for older people (over 65) who are socially isolated or with unpaid carers experiencing high levels of stress due to their caring responsibilities. The criteria for these services mean that the majority of service users are aged over 80 years old. One to one days services recognise that older people are not a homogenous group, and offering personalised services.

Disability – Day services provide support for older people who are frail, have mobility difficulties, physical disabilities, cognitive impairment, dementia and mental health issues. One to one day services can be of benefit to people who's needs mean that group day care settings are not appropriate. This may be because their level of mobility means they are housebound or have dementia or mental health needs that mean one to one support is required to reduce distress or facilitate engagement.

Sex, sexual orientation, marriage/ civil partnership – all day services must be welcoming of people of all gender identities and/ or sexual orientations. Activities should be personalised to the individual, based on their preferences, avoiding stereotypes or assumptions. One to one day services have the potential to match staff to a person that has an understanding of the person's identity, background or protected characteristics. The service specification includes the following in requirement of provider ' as far as reasonably possible, allocate staff and or volunteers to deliver the service in accordance with the individual needs, cultural, religious and gender preferences of the service user'

Negative Impacts

Age – The criteria for the service does exclude younger adults. However, the focus of the services on older, frail adults, means that the service is unlikely to be suitable for, and would not be chosen by, adults under 65. The City of Edinburgh Council provides and funds other services for younger adults with health and social care needs. However, each case will be considered on an individual basis.

Positive Impacts

The advancement of equality of opportunity is a key aspect of day services for older people, which aim to minimise any disadvantage faced by older people, whether through disability, dementia, frailty or isolation. The services are tailored to meet the needs of the people using the services in a personalised a way as possible. The Service is aimed at people who do not have equality of opportunity to access centre based day care due to their individual needs, such as mobility or level of dementia.

• The report on the findings of the consultation on the future of day services for older people from minority ethnic communities, shows how services tailored to the needs of older people from minority ethnic communities ('specialist' services) are valued by service users and families.
