## FIREWORKS (SCOTLAND) REGULATIONS 2004

### TERMS AND CONDITIONS

1. I wish to apply for a Dispensation to allow the use of fireworks on the times and dates detailed in the attached application form.
2. In making this application I understand that Regulation 3 of the Fireworks (Scotland) Regulations 2004 prohibits the use of adult fireworks during night hours being the period beginning at 23:00hrs and ending at 07:00hrs the following day.
3. I confirm that this application relates to a period outwith the following times:
  - beginning at 23.00 on the first day of the Chinese New Year and ending at 01.00 the following day
  - beginning at 23.00 on 5th November and ending at 24.00 on 5th November;
  - beginning at 23.00 on the day of Diwali and ending at 01.00 the following day; or
  - beginning at 23.00 on 31st December and ending at 01.00 the following day.
4. I confirm that I am a person:
  - employed by or in the business as a personal organiser of a firework display; or
  - employed by a Department of the United Kingdom Government, the Scottish Government, or an Agency of the Scottish Government; or
  - employed by the navy, military or air force of the Crown.
5. In submitting this application I confirm that the fireworks display / use of fireworks will result in no risk of:
  - death of persons or injury, alarm, distress or anxiety to persons;
  - death of animals or injury or distress to animals; and
  - destruction of, or damage to, property.
6. In submitting this application I confirm that the risk that the use of fireworks will have is the minimum that is compatible with their being used.
7. I understand that the event to which this application relates is at least six weeks after the date of this application. In compliance with the Fireworks (Scotland) Regulations 2004 I also confirm that, if this application is granted I shall give public notice of the event in a Newspaper circulating in the City of Edinburgh local authority area no later than seven days before the said event providing:
  - a description of the proposed fireworks display, national public celebration or national commemorative event;
  - details of the fireworks proposed to be used at the event;
  - the proposed location of the event; and
  - the proposed date or dates and hours during which fireworks shall be used at the event.
