The organisations have been given notice of this in one to one meetings and will have the opportunity to apply to the Children and Families grants programme for support for work that meet the department's priorities. #### **Positive Impacts**

Within the ontracts there will be an equalities statement stating that it is the duty of the commissioned service to comply with the Equalities Act 2010. Issues of non compliance will be picked up through regular monitoring of the service.

#### **Negative Impacts**

Failure to complete this work would result in contracts ceasing. Concerns have been raised about meeting the needs of vulnerable groups such as disabled young people, given the focus on universal services with reduced funding. To mitigate this, a strategic oversight group has ensured that issues of distribution across the strategic outcomes are addressed as part of the grants programme and with contracts.

#### **Positive Impacts**

Within the contracts, there will be an equalities statement that makes clear the duty of the commissioned services to comply with the Equalites Act 2010.

The views of young people will be central to the Youth Work service redesign. An online survey - designed with a group of young people - was circulated to a wide range of youth organisations and agencies, including those for young people with specific protected characteristics (e.g. disability; sexual orientation, EAL). Young people are involved in

analysing the findings and exploring issues in more depth through focus groups, which will also include young people with protected characteristics. 437 young people took part in the online survey.

#### **Negative Impacts**

Potential impact on budgets of unsuccessful applicants.

To mitigate this, a strategic oversight group has ensured that issues of distribution across the strategic outcomes are addressed as part of the grants programme and with contracts. Concerns have been raised about limiting the youth work contracts to services for young people aged 11-25 and not younger children. This is mitigated by revenue grant funding which is not limited in this way.

Positive Impacts		
It will be expected that staff employed by the commissioned service will be able to challenge and address inappropriate behaviour. To ensure this, there is a clause in the Terms and Conditions of Contract stating 'At all times, the Service Provider shall ensure that each of the		
Service Provider's Personnel is suitably qualified, adequately trained and capable of providing the applicable service in respect of which they are engaged.' Youth work provision supports multi-cultural awareness and challenges gender stereotypes.
