The provision of revenue grants to successful applicants is helping the Council to enhance all the rights highlighted above, especially for young people.

If the Participatory Budgeting process is approved, young people's rights as decision-makers will be significantly enhanced.

Positive Impacts

Each grant-aided service is required to comply with the Equalities Act 2010, thereby increasing awareness of the duty to eliminate discrimination. In particular, funding <u>has beenis</u> provided to several organisations which have a particularly keen awareness of discrimination against groups with protected characteristics (i.e. race, disability, sexual orientation, gender) as well as those affected by poverty and health inequalities and this contributes to the positive impact. <u>The criteria should ensure that this continues to be the case.</u>

The grant funding awards will support the strategic priorities of the Edinburgh Children's Partnership in particular SO2 and the Council and the duty to eliminate unlawful discrimination.

The Council will provide information on other potential sources of funding to unsuccessful applicants.

It is the duty of each grant-aided service to comply with the Equalities Act 2010. Issues of non compliance will be picked up through regular monitoring of the service.

The criteria for the grants and the proposed allocation of funding between citywide and locality awards and between different localities have all been shaped positively by equalities considerations (for example, the proposed citywide provision reflects the preferences of LGBT and BME young people; the proposed funding split between areas is based on the level of deprivation and numbers of young people in each area).

Prioritising open-access universal youth work will mean that services will have to actively seek to meet different needs and attract different groups.

Negative Impacts

Any potential issue of non compliance is picked up through regular monitoring of the service.

Organisations with a high degree of reliance (greater than 50%) on the Council's funding will be particularly sensitive to the proposal and any loss of funding from their principal donor

could have damaging consequences. Organisations currently awarded funding for this work have been managing reductions through 2016-17 as the service specifications have been amended. Many of these organisations will have gained funding through the main revenue grants programme and this funding runs until 2019.

The prioritising of open-access universal youth work may require a shift in service delivery by some organisations away from more targeted work.

The reduction of the overall budget will have some impact on service delivery.

Positive Impacts

Young people, including those with protected characteristics or from areas of deprivation, have been part of the process from start to finish – they have identified priorities, ranked criteria, set questions and will play a full part in assessment and potentially voting on successful projects.

The application process will weight in favour of applicants delivering services in areas of high deprivation or to young people from low income families or with a protected characteristic. Efforts will be made to ensure that young people with a protected characteristic, from areas of deprivation, who are looked after and accommodated will be made aware of PB process (if approved), for example by working with youth agencies, community groups, other services. The involvement of young people should ensure that youth work services meet the needs of young people more effectively.

PB encourages participation in democratic decision-making and community life, including awareness and understanding of other cultures.

Negative Impacts

The overall reduction in funding and the need to spread it across the city may result in negative impacts for some existing service users. £590k will be available across the city - there hasn't been a dedicated open access universal youth work budget before but this represents a reduction in funding. Some services which are currently funded may no longer receive funding or may receive less funding with consequent effects on service delivery unless other sources of funding can be found.

Positive Impacts

Funding for youth work services creates many positive impacts on this duty. Most of the programmes which will be supported bring together young people from different backgrounds in welcoming environments.

The overall reduction in funding may have an impact on service delivery but the PB process should help to prevent any negative impacts on good relations.
