Project Updates

Happy Christmas! This is the seventh CCWEL update. These are issued regularly to keep all stakeholders up to date. When construction commences on site (expected 2019), updates will be issued more frequently with details of construction and traffic management.

Latest Progress

Work is progressing well on the detailed design for Section 2, from Haymarket to Charlotte Square.

Meanwhile the statutory processes necessary to implement the changes along Section 1 (Roseburn to Haymarket) have begun. As part of these processes – a Traffic Regulation Order (TRO) and a Redetermination Order (RSO) – plans were issued to statutory consultees such as public transport operators, Community Councils and emergency services.

The next stage of the Order process, involves a public consultation which will take place early next year. The designs will be available online and all local residents and businesses will be notified. We will also host community drop-in sessions to ensure that everyone has the chance to view and comment on the proposals.

The legal process required to change taxi stance arrangements at Haymarket Station and Murrayfield Avenue has also started. The public will be able to comment on these proposals in January 2018.

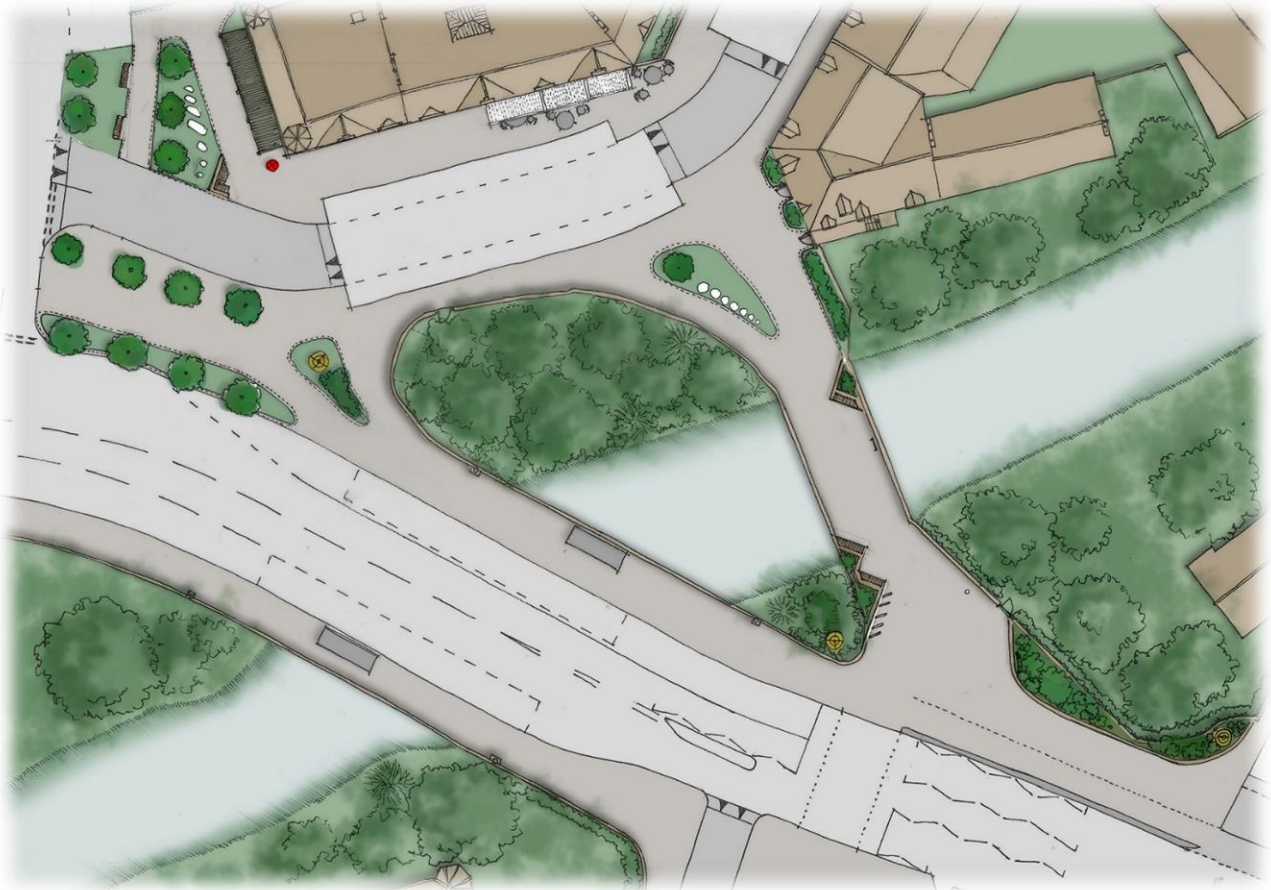
Rejuvenating Roseburn

During January we will develop a more detailed design based on Option 3, but incorporating some of the other ideas as well. Once this has been developed we will go to public consultation during February.

Following this the approved design will be worked into the Technical Design stage for Section 1 of the CCWEL project and will move to construction with the rest of the CCWEL during 2019.

In the next couple of months we will attend the meetings of Murrayfield Community Council to provide updates on how this work is progressing, and take
