Summary of Enhancements of Rights

The proposed amendments to parking charges on Greenways aim to improve the availability of parking places during the day and ensure that places are being used for short-term parking only. This will improve the accessibility of parking and address concerns regarding commuter parking. This may improve the **standard of living** for people with disabilities as controlling parking better may allow them to park closer to their intended destination.

Introducing parking charges in places which are currently free of charge will improve rights to **health**. This will encourage people who drive to use alternative forms of transport rather than their private vehicle and will help tackle pollution, cut carbon emissions and improve air quality for everyone.

As a result of this report there are no known enhancements of rights relating to;

Summary of Infringement of Rights. Can these infringements be justified? Are they proportional?

The proposed changes to pilot a cashless only service on main Greenways routes may infringe on the rights of individuals who are not able to read. However, they will already have passed mandatory tests to receive their license, completed the process of obtaining a vehicle, insuring it and taxing it.

In addition, people who do not have mobile phones or bank accounts may be somewhat inconvenienced if they are unable to pay to park using coins. However, promotional materials will help raise awareness of and encourage people to use cashless payment alternatives.

Introducing charges with coin only payments could be just as inconvenient as cashless only payments to people who do not carry change, however, this is not considered to be an equalities issue.

Positive Impacts

The introduction of parking charges is expected to be able to tackle all-day commuter parking better and improve the availability of parking spaces. This will increase the accessibility of parking places and this may improve access for disabled persons' blue badge holders.

Negative Impacts

The proposals to introduce parking charges on Greenways parking places are not expected to negatively discriminate, harass or victimize anyone with a protected characteristic.

Positive Impacts

If the proposal goes ahead this will help ensure that parking opportunities continue to be available for shoppers, business users and their customers near to their intended destinations. This will enhance the equality of opportunity for people with **disabilities** as they may not have been able to park in these locations previously, due to the high demand for free

parking, and been unable to walk greater distances to their destinations from other areas.

Negative Impacts

The proposals recommend introducing a pilot of cashless only parking charges on Greenways. This may have a negative impact on some people with **disabilities**. While disabled persons' blue badge holders will continue to be able to park free of charge in these parking places, consideration is given to whether people with disabilities who do not hold a blue badge will be disadvantaged. Reading information notices and paying for parking using a mobile device may cause problems for some people with learning difficulties (such as dyscalculia) or those with physical impairments. However, there are likely to be some people for whom the existing ticket machines are currently inaccessible to pay for their parking and raising awareness of cashless alternatives may be beneficial.

Another concern could regard **race** as people from some backgrounds may not be able to speak English or it may be used sparingly as a second language. Census 2011 data suggests that 8,600 people (1.9% of Edinburgh's population) do not speak English well or at all. Conveying the need to pay for parking by phone to such people could be difficult. However, RingGo offers information in alternative languages on its app and this could be argued to be more accessible for visitors or non-English speakers than currently paying by coin.

Another socio-economic factor which may impact on older people concerns those who do not have access to a mobile device or those who do not have a bank account. This group of people is most likely not to own a mobile phone. However, cashless parking services are well established throughout the UK, mobile phone ownership in Scotland is 86% and public pay phones are still available in many areas. The UK government has also helped launch fee-free bank accounts for people on low-incomes to tackle such problems. Furthermore, most wages and benefits are now paid directly into recipients' accounts which makes living without one and running a vehicle most unlikely.
