Part of the proposed SCSP 2017/18 programme involves encouraging awareness of walking and cycling opportunities in less affluent areas. It is envisaged that these services, such as guided walks and cycle rides, would be designed specifically to meet the needs of these groups of people, and to encourage these groups to make healthier choices about how they choose to travel. It is expected that these projects would have positive impacts and enhance the health/wellbeing of these groups of people.

Another focus of the SCSP 2017/18 programme is to enhance public spaces, in terms of street design. This would also have a positive effect on increasing participation in public life, to members of the public.

It is important to recognise disadvantage and seek to minimise this when delivering public services, and the SCSP 2017/18 will be designed with this in mind. (OK)
