### 2. What will change as a result of this proposal?

For most of the decisions taken, these are returning Council services to normal following a period of suspension or change arising following the outbreak of the COVID-19 pandemic.

The exception to this is in using East Princes Street Gardens (EPSG) where the decision was to allow Network Rail to use this area to support physical distancing during periods of high passenger numbers through Edinburgh Waverley Train Station. This arrangement, if required, will be managed

by Network Rail (NR) and utilises normal PSG paths. In advance of the decision, a site meeting took place with NR to ensure the arrangements were safe and took account of people with disabilities (particularly in respect of access issues due to steepness of paths).

In respect of Museums and Galleries, the approach is reopening on a phased basis, starting with City Art Centre (CAC). An online booking system has been introduced although this does not exclude people without access internet from visiting with telephone bookings available. In addition, people can turn up at CAC without a booking but they will not be guaranteed automatic entry. The lift is not in use, except when agreed with CAC staff. Guided routes through venue have been set up to ensure safety of customers. Further activity is available digitally, including resources for schools. Target audience for the reopened facility is local residents.

For marriage and civil partnership ceremonies, the Scottish Government routemap permitted these to be reinstated, firstly outside and then indoors. The arrangements in place are in line with the Scottish Government guidance, including ensuring that physical distancing can be supported, limiting number of people attending to 15, attendees are required to wear masks throughout the ceremony and Concierge staff are opening/closing the venue. A Health and Safety assessment has been undertaken.

For parking permits – this is a return to business as usual, reintroducing charges. An IIA for suspending parking charges was previously prepared.

For filming in the city, this was to support a return to permitting filming in the city, in line with Scottish Government guidance and in accordance with the Council's Filming Charter and Code of Practice.

For Parks and Greenspace, this decision permitted the reopening playgrounds as part of Phase 2 routemap at the appropriate time. Health and Safety checks took place prior to reopening, signage was changed to include generalised reminders on physical distancing and use of hand sanitiser. Car parks which were closed due to restrictions in travel were reopened (except upper car park at Bonaly which remained closed to allow access for emergency services and mountain rescue).

#### 3. Briefly describe public involvement in this proposal to date and planned

These decisions were taken swiftly by Council Incident Management Team (CIMT), making changes to Council services and were based on officer recommendation. These decisions were taken in discussion with the Council Leader and Depute Leader.

The approach being taken includes working closely with public and voluntary sector partners but there was not time for specific public involvement in the development of plans. As resources have allowed, changes have been made to reinstate services or to adapt services further.
