



THE CITY OF EDINBURGH COUNCIL (WEST APPROACH ROAD) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/62

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as "The City of Edinburgh Council (West Approach Road) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect during the hours and on the dates specified in the Schedules to this Order.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for police, fire or ambulance purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate the construction of a new cycle lane (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on the road specified in Schedule 1 hereto; and
 - (b) drive or cause or permit to be driven any vehicle on the road specified in column 1 of Schedule 2, to drive at a speed in excess of that specified in column 2 of Schedule 2, which shall reduce the speed limit from that specified in column 3 of Schedule 2 hereto.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles connected to the works.
5. ‘The Lothian Regional Council (West Approach Road, Edinburgh) (40 mph Speed Limit) Order 1982’ shall be suspended from Twenty-seventh day of February Two thousand and twenty-three up to and including the Sixteenth day of March Two thousand and Twenty-four in relation to the affected section of **West Approach Road** described in Schedule 2 of this Order.
6. The alternative routes for through vehicular traffic with respect to the closure will be by way of (i) *eastbound* – Westfield Road, Stevenson Road, Balgreen Road, Gorgie Road, Henderson Terrace and Dundee Street; and (ii) *westbound* – Henderson Terrace, Gorgie Road and Balgreen Road.
