## **ROADS (SCOTLAND) ACT 1984**

The City of Edinburgh Council proposes to make an Order under sections 1(1) and 152(2) of the Roads (Scotland) Act 1984 redetermining the roads described in the Schedule hereto. The title of the Order is "The City of Edinburgh Council (Northfield Grove and Northfield Drive, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 202-" - RSO/23/18. A copy of the proposed Order and of the accompanying plans showing the roads over which the means of exercise of the public right of passage is to be redetermined, together with a statement of the reasons for making the Order can be viewed free of charge, between 9:30 to 15:30 Mon-Fri from 02/06/23 to 30/06/23 at Waverley Court Reception or online during the same period <a href="www.tellmescotland.gov.uk">www.tellmescotland.gov.uk</a>. <u>SCHEDULE 1</u> ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO FOOTWAY

Northfield Drive (South-east Side) a) All that part of the carriageway on the south-east side of Northfield Drive from a point 13.1 metres or thereby north-east of the centreline of the junction of Northfield Drive and Northfield Grove, south-westwards for a distance of 8.9 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby. b) All that part of the carriageway on the south-east side of Northfield Drive and the south-west side of Northfield Grove, from a point 11.2 metres or thereby south-west of the centreline of the junction of Northfield Drive and Northfield Grove, north-eastwards and then south-eastwards to a point 8.5 metres or thereby south-east of the intersection of the southeast kerbline of Northfield Drive and the south-west kerbline of Northfield Grove and which has a width that varies from 0 metres or thereby to 1.5 metres or thereby. c) All that part of the carriageway on the south-east side of Northfield Drive from a point 2.8 metres or thereby south-west of the most north-east kerbline of the layby outside No. 26 Northfield Drive, northeastwards for a distance of 4.8 metres or thereby and which has a width that varies from 7.3 metres or thereby to 0 metres or thereby. d) All that part of the carriageway on the south-east side of Northfield Drive from a point 23.8 metres or thereby south-west of the north-east kerbline of the layby outside No. 26 Northfield Drive, south-westwards for a distance of 2.8 metres or thereby and which has a width throughout of 7.2 metres or thereby. e) All that part of the carriageway on the south-east side of Northfield Drive from a point 9 metres or thereby north-east of the extended north-east building line of No. 2 Northfield Drive, south-westwards for a distance of 4.5 metres or thereby and which has a width that varies from 7.2 metres or thereby to 0 metres or thereby. Northfield Grove (North-east Side) a) All that part of the carriageway on the north-east side of Northfield Grove from a point 2.3 metres or thereby south of the north kerbline of Northfield Grove (north-east limb adjacent to No. 1 Northfield Grove), south-eastwards for a distance of 10.1 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby. (South-west Side) a) See Northfield Drive (south-east side) item b). (East Side) a) All that part of the carriageway on the east side of Northfield Grove from the north kerbline of Northfield Grove (north-east limb adjacent to No. 1 Northfield Grove), southwards for a distance of 31.2 metres or thereby, excluding the areas of the carriageway being changed to verge (marked Areas H, I, J and K on the associated plans), and has a width that varies from 0 metres or thereby to 9.7 metres or thereby. b) All that part of the carriageway on the east side of Northfield Grove from a point

31.2 metres or thereby south of the north kerbline of Northfield Grove (north-east limb adjacent to No. 3 Northfield Grove), southwards for a distance of 2.8 metres or thereby and which has a width that varies from 4.2 metres or thereby to 3.2 metres or thereby. c) All that part of the carriageway on the east side of Northfield Grove from a point 56.4 metres or thereby south of the north kerbline of Northfield Grove (north-east limb adjacent to No. 3 Northfield Grove), northwards for a distance of 13.1 metres or thereby and which has a width that varies from 4.7 metres or thereby to 0 metres or thereby. d) All that part of the carriageway on the east side of Northfield Grove from a point 77.8 metres or thereby south of the north kerbline of Northfield Grove (north-east limb adjacent to No. 5 Northfield Grove), southwards for a distance of 6 metres or thereby and which has a width that varies from 1.2 metres or thereby to 5.5 metres or thereby. (North-west Side) a) All that part of the carriageway on the north-west side of Northfield Grove, from a point 8.1 metres or thereby south-west of the extended south-west building line of No. 32 Northfield Grove, southwestwards for a distance of 1 metre or thereby and which has a width throughout of 2.6 metres or thereby. b) All that part of the carriageway on the north-west side of Northfield Grove, from a point 21.5 metres or thereby south-west of the extended south-west building line of No. 32 Northfield Grove, north-eastwards; for a distance of 2.8 metres or thereby and which has a width that varies from 7.6 metres or thereby to 5 metres or thereby. c) All that part of the carriageway on the north-west side of Northfield Grove, from a point 10.6 metres or thereby south-west of the extended south-west building line of No. 24 Northfield Grove, south-westwards for a distance of 1 metre or thereby and which has a width throughout of 2.6 metres or thereby. d) All that part of the carriageway on the north-west side of Northfield Grove, from a point 21.6 metres or thereby south-west of the extended south-west building line of No. 24 Northfield Grove, north-eastwards for a distance of 2.9 metres or thereby and which has a width that varies from 7.6 metres or thereby to 5 metres or thereby. (South-east Side) a) All that part of the carriageway on the south-east side of Northfield Grove from a point 57.2 metres or thereby north-east of the south-west kerbline of Northfield Grove (southwest limb adjacent to Nos. 7 & 9 Northfield Grove), north-eastwards for a distance of 23 metres or thereby, excluding the areas of the carriageway being changed to verge (marked Areas P, Q, R and S on the associated plans), and which has a width that varies from 25.1 metres or thereby to 0.5 metres or thereby. b) All that part of the carriageway on the southeast side of Northfield Grove from a point 41.9 metres or thereby north-east of the southwest kerbline of Northfield Grove (south-west limb adjacent to Nos. 9 to 15 Northfield Grove), north-eastwards for a distance of 1 metre or thereby and which has a width throughout of 2.5 metres or thereby. c) All that part of the carriageway on the south-east side of Northfield Grove, from a point 31.9 metres or thereby north-east of the south-west kerbline of Northfield Grove (south-west limb adjacent to Nos. 9 to 15 Northfield Grove), north-eastwards for a distance of 2.8 metres or thereby and which has a width that varies from 7.5 metres or thereby to 5 metres or thereby. d) All that part of the carriageway on the south-east side of Northfield Grove, from the south-west kerbline of Northfield Grove (south-west limb adjacent to Nos. 9 to 15 Northfield Grove), north-eastwards for a distance of 4.2 metres or thereby and which has a width throughout of 4 metres or thereby.

<u>SCHEDULE 2</u> ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM FOOTWAY TO CARRIAGEWAY **Northfield Drive (South-east Side) a)** All that part of the footway on the south-east side of Northfield Drive from a point 4.1 metres or thereby north of the intersection of the west kerbline of the layby outside Nos. 36-42 Northfield Drive and the south-east kerbline of Northfield Drive, south-westwards for a distance of 22.8 metres or thereby and which has a

width that varies from 0 metres or thereby to 1.9 metres or thereby. b) All that part of the footway on the south-east side of Northfield Drive from a point 25.1 metres or thereby northeast of the extended north-east building line of No. 2 Northfield Drive, north-eastwards for a distance of 4 metres or thereby and which has a width that varies from 0 metres or thereby to 7.4 metres or thereby. Northfield Grove (Traffic island on the north-east of the road) a) All that part of the footway on the north-east side of Northfield Grove (northern section of the traffic island), from the most northern point of the traffic island, southwards for a distance of 4 metres or thereby and which has a width that varies from 0 metres or thereby to 5.4 metres or thereby. b) All that part of the footway on the north-east side of Northfield Grove (southern section of the traffic island), from the most southern point of the traffic island, northwards for a distance of 7.5 metres or thereby and which has a width that varies from 0 metres or thereby to 6.5 metres or thereby. (North-west Side) a) All that part of the footway on the north-west side of Northfield Grove from the extended north-east building line of No. 24 Northfield Grove, south-westwards for a distance of 9.9 metres or thereby and which has a width that varies from 8.3 metres or thereby to 6.5 metres or thereby. (South-east Side) a) All that part of the footway on the south-east side of Northfield Grove from a point 49.9 metres or thereby north-east of the south-west kerbline of Northfield Grove (south-west limb adjacent to Nos. 7 & 9 Northfield Grove), north-eastwards for a distance of 11.8 metres or thereby and which has a width that varies from 2.6 metres or thereby to 0.6 metres or thereby.
