THE CITY OF EDINBURGH COUNCIL (A71, CALDER ROAD AND DALMAHOY ROAD, EDINBURGH) (40MPH SPEED LIMIT) AND (30 MPH SPEED LIMIT) ORDER 2023 - TRO/22/06


The City of Edinburgh Council in exercise of their powers under Sections 82(2) and 83(2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended by the Roads (Scotland) Act 1984 (which Act as so amended is hereinafter referred to as "the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:

1. This Order may be cited as "The City of Edinburgh Council (A71, Calder Road and Dalmahoy Road, Edinburgh) (40 mph Speed Limit) and (30 mph Speed Limit) Order 2023" and shall come into operation on the twenty-sixth day of June Two thousand and twenty three.
2. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 1 to this Order.
4. The Lothian Regional Council (A71, Calder Road – Edinburgh to Wilkieston) (40 mph Speed Limit) Traffic Regulation Order 2018 shall have effect subject to the variations, insertions, substitutions and additions thereto specified in Schedule 2 to this Order.

SCHEDULE 1

30 M.P.H. SPEED LIMIT

LENGTHS OF ROAD

A71, Calder Road	From a point 300 metres or thereby east of its junction with Dalmahoy Road to a point 925 metres or thereby west of its junction with Dalmahoy Road.
Dalmahoy Road	From its junction with A71, Calder Road for a distance of 300 metres or thereby northwards.

Explanatory Note - The lengths of road in this Order are in addition to the lengths of restricted road described in the entries in Part I – Edinburgh District of the Schedule to the Lothian Regional Council (Restricted Roads) Order 1985.

SCHEDULE 2

THE Lothian Regional Council (A71, Calder Road – Edinburgh to Wilkieston) (40 MPH Speed Limit) Traffic Regulation Order 2018

In SCHEDULE 1

in item A71, Calder Road for the words “From a point 300 metres or thereby east of its junction with Dalmahoy Road to a point 925 metres or thereby west of its junction with Dalmahoy Road.” there were substituted the words “Not Allocated”.

in item Dalmahoy Road for the words “From its junction with A71, Calder Road for a distance of 300 metres or thereby northwards.” there were substituted the words “Not Allocated”.
