THE CITY OF EDINBURGH COUNCIL (LAWNMARKET, MOUND PLACE & NORTH BANK STREET) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/148

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- This Order may be cited as "The City of Edinburgh Council (Lawnmarket, Mound Place & North Bank Street) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect during the hours and on the dates specified in the Schedule to this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4 of this Order, to facilitate the holding of assembly festival events in the area (as signed as affected by the events), no person shall, except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads described in Schedule 1 hereto.
- 4. Nothing in Article 3 shall apply to emergency service vehicles.

5. The 2018 Order is hereby suspended in so far as it is affected by the measures described in Article 3 of this Order.

SCHEDULE 1 PROHIBITION OF WAITING, LOADING & UNLOADING

(A) from 07:00 hours on 19/07/2023 to 23:59 hours on 21/07/2023 on:

Lawnmarket, *north side*, from a point 39 metres or thereby east of the projected easternmost extremity of Jollie's Close, eastwards for a distance of 25 metres or thereby.

(B) from 07:00 hours on 03/07/2023 to 23:59 hours on 31/08/2023 on:

Mound Place, *south side*, from the point it adjoins the layby car parking area on North Bank Street, westwards for a distance of 21 metres or thereby.

(C) <u>from 07:00 hours on 20/07/2023 to 23:59 hours on 31/08/2023</u> on:

North Bank Street, *south side* (layby section), from a point 6 metres or thereby west of the bollards bordering North Bank Street (*north-south section*), westwards for 2.5 metres or thereby.
