THE CITY OF EDINBURGH COUNCIL (EDINBURGH TRAM NETWORK, EDINBURGH)
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2019 -
TEMP/19/210

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984, as amended by the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf hereby make the following Order to facilitate the Edinburgh Tram Network:-

1. This Order may be cited as "The City of Edinburgh Council (Edinburgh Tram Network) (Temporary Road Restriction and Traffic Regulation) Order 2019" and shall come into operation on the Sixteenth day of November Two thousand and nineteen. The City of Edinburgh Council is satisfied that the execution of the works referred to in this Order will take in excess of eighteen months.
2. Save as provided in Article 3 and 4 of this Order, to facilitate the utilities diversions and related works required in connection with the Edinburgh Tram Network the use of the roads specified in the Schedule 1 attached hereto shall be prohibited, restricted or regulated from time to time by one or more of the measures specified in Schedule 2 attached hereto, all as signed on street as affected by the works.
3. Nothing in Article 2 of this Order shall apply to any vehicle which is there in actual connection with the works.
4. Access for emergency vehicles will be maintained. Pedestrian traffic and access will be maintained.
5. The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018, as amended, shall be suspended for the duration of this Order in relation to the affected residents', car club, shared use, disabled, motorcycle, pay and display, limited waiting and loading bays in so far as they are affected by the prohibitions and restrictions specified in Article 2 of this Order.
