## THE CITY OF EDINBURGH COUNCIL (PARKGROVE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/131

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Parkgrove Area) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect from the Tenth day of July Two thousand and twenty-three up to and including the First day of October Two thousand and twenty-three.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4, to facilitate pedestrian improvement works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on (i) **Clermiston Avenue**, at its junction with Parkgrove Street; (ii) **Parkgrove Place**, at its junction with Parkgrove Street; and (iii) **Parkgrove Street**: (1) at its junction with Parkgrove Terrace; and (2) at its junction with Queensferry Road; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on (i) Clermiston Avenue, both sides, from its junction with Parkgrove Street, eastwards for a distance of 30 metres or thereby; (ii) Parkgrove Place, both sides, from its junction with Parkgrove Street, westwards for a distance of 30 metres or thereby; (iii) Parkgrove Road, east side, from its junction with Parkgrove Terrace, northwards and southwards for a distance of 15 metres or thereby respectively; (iv) Parkgrove Street, both sides, between its junction with Queensferry Road and its junction with Parkgrove Terrace; and (v) Parkgrove Terrace, both sides, from its junction with Parkgrove Road, eastwards for a distance of 30 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the measures described in Article 3(b) of this Order.
- 6. 'The Lothian Regional Council (Parkgrove Place, Edinburgh) (One-Way) Traffic Regulation Order 1995' shall be suspended on **Parkgrove Place**, to facilitate two-way traffic.

7. The alternative routes for through vehicular traffic with respect to the *closures* will be by way of: (i) Clermiston Avenue – Parkgrove Street, Parkgrove Terrace, Clermiston Green and Clermiston Loan; and (iii) Parkgrove Street: (1) Parkgrove Terrace and Parkgrove Place; or Clermiston Avenue, Clermiston Loan, Clermiston Green and Parkgrove Terrace; and (2) Queensferry Road, Parkgrove Avenue and Parkgrove Terrace; or Parkgrove Street, Parkgrove Terrace, Clermiston Crescent, Drum Brae Drive and Clermiston Road North.
