## THE CITY OF EDINBURGH COUNCIL (DUNDEE STREET) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/147

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Dundee Street) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect from the Tenth day of July Two thousand and twenty-three up to and including the Twenty-fourth day of July Two thousand and twenty-three.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire or police purposes;
  - "motor vehicle" has the same meaning as in Section 136 of the 1984 Act
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4 of this Order, to facilitate a safe working area for the installation of a new telecommunications pole (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit any motor vehicle to be driven on **Dundee Street**, between the extended south-western kerbline of the vehicular exit from Fountainbridge Leisure Park, south-westwards to the extended eastern kerbline of the vehicular entrance to Fountainbridge Leisure Park, otherwise than in a *south-westbound* direction; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of **Dundee Street**, from a point 40 metres or thereby south-west of the extended south-western kerbline of Gibson Terrace, north-eastwards for a distance of 150 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the measures described in Article 3(b) of this Order.
- 6. The alternative route for through vehicular traffic will be by way of Yeaman Place, Polwarth Crescent, Granville Terrace and Viewforth.
