## THE CITY OF EDINBURGH COUNCIL (MYRESIDE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/154

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Myreside Area) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect from the Tenth day of July Two thousand and twenty-three up to and including the Eleventh day of September Two thousand and twenty-three.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984; and "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.
- 3. Save as provided in Article 4 of this Order, to facilitate SGN mains renewal works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit any vehicle to be driven on (i) **Mid Gillsland Road**, at its junction with Colinton Road; and (ii) **South Ettrick Road**, at its junction with Colinton Road;
  - (b) drive or cause or permit any vehicle to be driven on **South Gillsland Road**, between its junction with Merchiston Gardens and its junction with Colinton Road, otherwise than in a *southbound* direction; and
  - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of (i) Colinton Road, between its junction with Tipperlinn Road and its junction with Mid Gillsland Road; (ii) South Gillsland Road, in its entirety; (iii) Merchiston Gardens, in its entirety; (iv) Myreside Court, from its junction with Craighouse Road, north-westwards for a distance of 30 metres or thereby; (v) Meadowspot, from its junction with Craighouse Road, westwards for a distance of 40 metres or thereby; (vi) Myreside Road, in its entirety; (vii) Craighouse Road, from its junction with Myreside Road, southwards to its junction with Craighouse Avenue; (viii) Craighouse Gardens: (1) from its junction with Craighouse Gardens, eastwards for a distance of 75 metres or thereby; and (2) from its junction with Balcarres Street, westwards for a distance of 100 metres or thereby; (ix) Balcarres Street, from its junction with Craighouse Gardens, generally eastwards for a distance of 420 metres or thereby; and (x) Bruce Street, in its entirety.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the measures described in Article 3(c) of this Order.

- 6. The alternative routes for through vehicular traffic with respect to the *closures* will be by way of: (i) **Mid Gillsland Road** Mid Gillsland Road, Spylaw Road, Gray's Loan and Colinton Road; and (ii) **South Ettrick Road** South Ettrick Road, Spylaw Road, Gray's Loan and Colinton Road.
- 7. The alternative route for through vehicular traffic with respect to the *one-way restriction* will be by way of Merchiston Gardens and Colinton Road.
