Representations and objections should state the name and address of the objector, the matters to which they relate and the grounds on which they are made. After the 28 day period the Order will be confirmed as an unopposed Order by the Council or submitted to the Scottish Ministers for consideration as an opposed Order. SCHEDULE LENGTHS OF ROAD TO BE STOPPED UP: Dalry Rd (east side) (1) All that part of Dalry Rd from a point 22.65m or thereby south-west of the extended south kerbline of Morrison St for a distance of 6.69m or thereby south-westwards and has a width that varies from 0m or thereby to 1.69m or thereby, (2) All that part of Dalry Rd from a point 10.91m or thereby south-west of the extended south kerbline of Morrison St for a distance of 1.63m or thereby south-westwards and has a width that varies from 0.32m or thereby to 0.58m or thereby (3) All that part of Dalry Rd from a point 9.22m or thereby south-west of the extended south kerbline of Morrison St for a distance of 1.23m or thereby south-westwards and has a width that varies from 0m or thereby to 1.15m or thereby. (4) All that part of Dalry Rd from a point 7.82m or thereby south-west of the extended south kerbline of Morrison St for a distance of 0.79m or thereby south-westwards and has a width that varies from 0m or thereby to 0.31m or thereby, Morrison St (south side) (5) All that part of Morrison St from a point 16.85m or thereby east of the extended east kerbline of Dalry Rd for a distance of 1.2m or thereby eastwards and has a width that varies from 0m or thereby to 1.14m or thereby.
