
### THE CITY OF EDINBURGH COUNCIL (NATIONS SERIES SUMMER TESTS @ BT MURRAYFIELD) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/170

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 62 of the Roads (Scotland) Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -


1. This Order may be cited as "The City of Edinburgh Council (Nations Series Summer Tests @ BT Murrayfield) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect during the hours and on the dates specified in Schedules to this Order.
2. In this Order the following phrases have the meanings respectively assigned to them:
  - “Article” means an Article of this Order;
  - “authorised vehicle” means any vehicle authorised by City of Edinburgh Council as being connected with the event;
  - “emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
  - “Parking Attendant” has the same meaning as in Section 63A of the Road Traffic Regulation Act 1984;
  - "public service vehicle" has the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981, and, for the purposes of this Order, applies where the said vehicle or vehicles are being operated as a Local Service, as defined in the said Act;
  - "road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this Order, includes part of a road;
  - “Schedule” means a Schedule to this Order;
  - “service buses” means a public service vehicle used for the provision of a local service not being an excursion or tour, and for the purposes of this Order, includes event specific service buses;
  - “tram” shall have the meaning assigned to that phrase by Section 82 of the Edinburgh Tram (Line One) Act 2006; and
  - “vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate the safe ingress and egress of spectators from BT Murrayfield (as signed as affected by the event), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on the roads specified in Schedule 1 hereto, where prohibitions will apply to roads in their entirety unless otherwise stated;
  - (b) walk or cause or permit any person to walk in the footways described in Schedule 2 hereto;
  - (c) drive or cause or permit to be driven any motor vehicle on the sections of roads specified in column 1 of Schedule 3, otherwise than in the direction specified in column 2 of Schedule 3 hereto;
  - (d) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the roads described in Schedule 4 hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated; and
  - (e) drive or cause or permit to be driven any vehicle on the road described in column 1 of Schedule 5 so as to make the prohibited turn specified in column 2 of Schedule 5, into the road specified in column 3 of Schedule 5 hereto.

4. Nothing in:
- (i) Article 3(a) of this Order shall apply to *authorised vehicles* on the sections of **Riversdale Crescent, Riversdale Road, Riversdale Grove, Saughtonhall Circus, Saughtonhall Terrace, Saughtonhall Grove, Saughtonhall Place, Saughtonhall Gardens, Saughtonhall Avenue, Baird Grove, Baird Terrace, Baird Gardens, Baird Avenue and Baird Drive** described in Schedule 1;
  - (ii) Article 3(a) of this Order shall apply to *service buses* on the sections of (i) **Western Terrace/Corstorphine Road**; and (ii) **Murrayfield Road** described in Schedule 1;
  - (iii) Article 3(a) of this Order shall apply to *event specific service buses* on the sections of (i) **West Approach Road**; and (ii) **Westfield Road** described in Schedule 1;
  - (iv) Article 3(a) and (c) of this Order shall apply to *trams* on the sections of (i) **Haymarket Terrace**; (ii) **Clifton Terrace**; (iii) **Haymarket Yards**; and (iv) **West Maitland Street** described in Schedules 1 & 3; and
  - (v) Article 3 of this Order shall apply to emergency service vehicles.
5. Whilst this Order continues in force, ‘The City of Edinburgh Council (Greenways) Order 1997’, ‘The City of Edinburgh Council (CCWEL Haymarket Terrace Area) (Temporary Road Restriction and Traffic Regulation) Order 2023’, ‘The City of Edinburgh Council (West Approach Road) (Temporary Road Restriction and Traffic Regulation) Order 2023’, ‘The City of Edinburgh Council (Haymarket One-Way Roads) (Temporary Road Restriction and Traffic Regulation) Order 2023’ and ‘The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018’ will be suspended during the hours and on the dates specified in the Schedules on any of the affected sections of roads described.
6. The alternative route for through vehicular traffic with respect of the closures will be by way of Ellersly Road, Murrayfield Road, Ravelston Dykes, Belford Road, Palmerston Place, Queensferry Terrace, Queensferry Road, Queensferry Street, Westfield Road, Gorgie Road, Dalry Road, Henderson Terrace and Dundee Street. Pedestrian access will be maintained on all roads, except in Article 3(b).

SCHEDULE 1  
PROHIBITION OF VEHICLES

(A) from 13:15 hours to 19:15 hours on 29/07/2023 and 05/08/2023; and from 15:30 hours to 21:30 hours on 26/08/2023 on:

(i) **Riversdale Crescent**; (ii) **Riversdale Road**; (iii) **Riversdale Grove**; (iv) **Saughtonhall Circus**; (v) **Saughtonhall Terrace**; (vi) **Saughtonhall Grove**; (vii) **Saughtonhall Place**; (viii) **Saughtonhall Gardens**; (ix) **Saughtonhall Avenue**; (x) **Baird Grove**; (xi) **Baird Terrace**; (xii) **Baird Gardens**; (xiii) **Baird Avenue**; and (xiv) **Baird Drive**.

(B) from 13:15 hours to 15:00 hours and then 16:15 hours to 19:15 hours on 29/07/2023 and 05/08/2023; and from 15:30 hours to 17:30 hours and then 18:30 hours to 21:30 hours on 26/08/2023 on:

(i) **Roseburn Street**; (ii) **Riversdale Bridge**; and (iii) **Russell Road**, from its junction with Roseburn Street, south-eastwards for a distance of 60 metres or thereby.

(C) from 13:45 hours to 15:00 hours and then 16:15 hours to 19:15 hours on 29/07/2023 and 05/08/2023; and from 16:00 hours to 17:30 hours and then 18:30 hours to 21:30 hours on 26/08/2023 on:

(i) **Roseburn Terrace**; (ii) **West Coates**; (iii) **Haymarket Terrace** (*except Trams*); (iv) **Clifton Terrace** (*except Trams*); (v) **Haymarket Yards** (*except Trams*); (vi) **Western Terrace/Corstorphine Road**, between its junction with Ellersly Road and its junction with Roseburn Terrace (*except service buses*); and (vii) **Murrayfield Road**, between its junction with Ellersly Road and its junction with Corstorphine Road (*except service buses*).

(D) from 16:15 hours to 19:15 hours on 29/07/2023 and 05/08/2023; and from 18:30 hours to 21:30 hours on 26/08/2023 on:

(i) **West Approach Road**, from its junction with Westfield Road to the slip road at Dundee Street/Angle Park Terrace (*except event specific service buses*); (ii) **Westfield Road**, from a point 95 metres or thereby north-east of the extended north-eastern kerblines of Westfield Avenue, north-eastwards to the West Approach Road (*except event specific service buses*); (iii) **Rosebery Crescent**, between its junction with Haymarket Terrace and its junction with Grosvenor Gardens; (iv) **Balbirnie Place**; and (v) **Grosvenor Street**, at its junction with West Maitland Street/Haymarket.

SCHEDULE 2  
PROHIBITION OF PEDESTRIANS

From 16:15 hours to 19:15 hours on 29/07/2023 and 05/08/2023; and from 18:30 hours to 21:30 hours on 26/08/2023 on:

**Balbirnie Place**: (i) from the projected south-west gable end of No. 50 Balbirnie Place, south-eastwards for a distance of 20 metres or thereby; and (ii) *the north-eastern footway*, from the projected south-western gable end of No. 50 Balbirnie Place, north-westwards for a distance of 30 metres or thereby.

ONE-WAY ROADS

From 13:45 hours to 15:00 hours and then 16:15 hours to 19:15 hours on 29/07/2023 and 05/08/2023; and from 16:00 hours to 17:30 hours and then 18:30 hours to 21:30 hours on 26/08/2023 on:

SCHEDULE 4  
PROHIBITION OF WAITING, LOADING AND UNLOADING

From 09:45 hours to 19:15 hours on 29/07/2023 and 05/08/2023; and from 12:00 hours to 21:30 hours on 26/08/2023 on:

(i) **Balgreen Road:** (a) *north-east side*, in its entirety; and (b) *south-west side*: (1) between its junction with Balgreen Avenue and its junction with Corstorphine Road; and (2) between its junction with Glendevon Road and its junction with Gorgie Road; (ii) **Corstorphine Road:** (a) *north side*, between its junction with Roseburn Terrace and its junction with St. John's Road; and (b) *south side*, between its junction with Western Corner/Saughtonhall Drive and its junction with St. John's Road; (iii) **Gorgie Road:** (a) *both sides*, between its junction with Balgreen Road and its junction with Chesser Avenue (*except recessed parking bays on the south side*); and (b) *north side*, between its junction with Balgreen Road and its junction with Westfield Road; (iv) **Roseburn Street, both sides:** (1) between its junction with Westfield Road and its junction with Roseburn Avenue; and (2) between its junction with Roseburn Terrace and its junction with Roseburn Place; (v) **Saughtonhall Avenue;** (vi) **Russell Road, north-east side**, from its junction with Roseburn Street, south-eastwards for a distance of 60 metres or thereby (*to the entrance to the private parking area*); (vii) **Roseburn Terrace;** (viii) **Murrayfield Road;** (ix) **Westfield Road, both sides**, between its junction with Roseburn Street and its junction with Westfield Avenue; (x) **Riversdale Crescent:** (a) *north-west side*, from its junction with Corstorphine Road, south-westwards for a distance of 120 metres or thereby; and (b) *south-east side*, in its entirety; (xi) **Riversdale Road, east side**, between its junction with Saughtonhall Avenue and its junction with Riversdale Crescent; (xii) **Ellersly Road;** (xiii) **Saughtonhall Drive, west side**, from its junction with Corstorphine Road, southwards for a distance of 45 metres or thereby; (xiv) **Ravelston Dykes Road, both sides**, from its junction with Murrayfield Road, westwards for a distance of 60 metres or thereby; (xv) **Ravelston Dykes:** (a) *north side*, from its junction with Murrayfield Road, eastwards to a point 40 metres or thereby east of Garscube Terrace; and (b) *south side*, from opposite Craigleith Crescent, eastwards to a point 40 metres or thereby east of Garscube Terrace (*excluding recessed bays*); (xvi) **Balbirnie Place, both sides**, from a point 30 metres or thereby north-west of the entrance to Roseburn Path to a point 30 metres or thereby south-east of the entrance to Roseburn Path; (xvii) **West Coates;** (xviii) **Haymarket Terrace;** and (xix) **Clifton Terrace.**
