THE CITY OF EDINBURGH COUNCIL (ROYAL EDINBURGH MILITARY TATTOO) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/173

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Royal Edinburgh Military Tattoo) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect during the hours and on the dates specified in the Schedules to this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "authorised vehicle" means any vehicle that can, upon request, provide a valid accredited pass authorised by the City of Edinburgh Council and is associated with the Royal Edinburgh Military Tattoo events for the duration of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "EIF pass" means a valid accredited Edinburgh International Festival pass;
  - "event vehicle" means any vehicle authorised by City of Edinburgh Council as being connected with the event, and for the purposes of this Order, includes event related coaches/buses;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "pass" means an official pass issued by the City of Edinburgh Council's representatives for the purpose of this Order;
  - "Schedule" means a Schedule to this Order;
  - "taxi" has the same meaning as in Section 23 of the Civic Government (Scotland) Act 1982; "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate the safe passage of pedestrian traffic, secure access to Edinburgh Castle in the event of an emergency and ensure the public safety of spectators entering and leaving Edinburgh Castle Esplanade and the dispersal of participants in the Royal Edinburgh Military Tattoo (as signed as affected by the event), no person shall:-
  - (a) drive or cause or permit to be driven any motor vehicle on the sections of roads specified in Schedule 1 hereto, where prohibitions will apply to roads in their entirety unless otherwise stated; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads specified in Schedule 2 hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.

## 4. Nothing in:

- (i) Article 3 shall apply to emergency services vehicles;
- (ii) Article 3(a) shall apply to official vehicles associated with the event (*including staff from Edinburgh Castle as agreed*);
- (iii) Article 3(a) shall apply to *authorised vehicles* on the sections of **Castlehill** and **St Giles' Street** described in Schedule 1 hereto;
- (iv) Article 3(a) shall apply to residents of, and bona fide visitors to Mound Place, North Bank Street, Castlehill, Ramsay Lane, Ramsay Garden, Lawnmarket and Upper Bow:
- (v) Article 3(a) shall apply to *event coaches and authorised vehicles* displaying an accredited Tattoo or EIF pass on the section of **King's Stables Road** described in Schedule 1 hereto;
- (vi) Article 3(b) shall apply to *authorised vehicles* on the sections of **Castlehill** and **Johnston Terrace** described in Schedule 2 hereto;
- (vii) Article 3(b) shall apply to *taxis* on the section of George IV Bridge described in Schedule 2 hereto; and
- (viii) Article 3(b) shall apply to *event coaches* displaying an accredited Tattoo pass on the sections of **Castle Terrace** and **King's Stables Road** described in Schedule 2 to this Order.
- 5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Schedule 2 of this Order.
- 6. Whilst this Order remains in force, 'The City of Edinburgh Council (Castlehill) (Temporary Road Restriction and Traffic Regulation) Order 2023' will be suspended to facilitate the safe operation of the Royal Edinburgh Military Tattoo.
- 7. The alternative route for through vehicular traffic will be by way of Castle Terrace, Lady Lawson Street, Lauriston Place, Forrest Road, Bristo Place, Teviot Place and George IV Bridge.

## SCHEDULE 1 PROHIBITION OF MOTOR VEHICLES

(A) <u>from 18:00 hours to 23:00 hours on 02/08/2023</u>; <u>and from 16:30 hours to 23:59 hours DAILY</u> <u>from 03/08/2023 to 26/08/2023</u> on:

**Castlehill** (except authorised vehicles displaying an appropriate accredited Tattoo pass).

- (B) from 17:00 hours to 23:59 hours on 02/08/2023 and 03/08/2023;
- (C) <u>from 17:00 hours to 23:59 hours (weekdays only) from 04/08/2023 to 17/08/2023; and from 21/08/2023 to 25/08/2023;</u> and
- (D) <u>from 16:00 hours to 23:59 hours on 05/08/2023, 12/08/2023, 18/08/2023, 19/08/2023 and 26/08/2023</u> on:
- (i) Mound Place; (ii) Ramsay Lane; (iii) Ramsay Garden; (iv) Johnston Terrace; (v) Lawnmarket, between its junction with Castlehill and its junction with George IV Bridge; (vi) Upper Bow; and (vii) Castle Wynd North.
- (E) <u>from 19:00 hours to 23:00 hours (weekdays only) from 04/08/2023 to 17/08/2023; and from 21/08/2023 to 25/08/2023</u> on:
- **St Giles' Street** (except authorised vehicles displaying an appropriate accredited Tattoo pass).
- (F) <u>from 19:00 hours to 23:59 hours (weekdays only) from 03/08/2023 to 17/08/2023; and from 21/08/2023 to 25/08/2023</u>; and
- (G) <u>from 16:15 hours to 23:59 hours on 05/08/2023, 12/08/2023, 18/08/2023, 19/08/2023 and 26/08/2023</u> on:

**King's Stables Road** (except event vehicles displaying the appropriate accredited Tattoo pass or EIF pass).

## SCHEDULE 2 PROHIBITION OF WAITING, LOADING & UNLOADING

- (A) <u>from 14:30 hours to 23:59 hours (weekdays only)</u>; and from 13:00 hours to 23:59 hours (<u>Saturday's</u>) from 02/08/2023 to 26/08/2023 on:
- (i) **Castlehill** (except authorised vehicles displaying the appropriate accredited pass); and (ii) **Lauriston Place**, both sides, between its junction with Forrest Road and its junction with Keir Street.
- (B) <u>from 14:30 hours to 23:59 hours (weekdays only) from 02/08/2023 to 17/08/2023; and from 21/08/2023 to 25/08/2023;</u> and
- (*C*) <u>from 13:00 hours to 23:59 hours on 05/08/2023, 12/08/2023, 18/08/2023, 19/08/2023 and 26/08/2023</u> on:
- (i) **Lawnmarket**, *both sides*, between its junction with Castlehill and its junction with George IV Bridge; (ii) **Johnston Terrace** (*except authorised vehicles displaying the appropriate accredited pass*); (iii) **Mound Place**: (1) *north side*, in its entirety (*except residents and bona fide visitors*); and (2) *south side*, from the point it adjoins Ramsay Lane, eastwards to a point 21 metres or thereby west of its junction with North Bank Street (*except residents and bona fide visitors*); (iv) **Candlemaker Row**; (v) **Ramsay Lane**; (vi) **Castle Terrace**: (1) *south side*, from its junction with Lothian Road,

south-eastwards for a distance of 87 metres or thereby; and (2) **both sides**, from its junction with Cambridge Street, south-eastwards for a distance of 172 metres or thereby (except event coaches displaying the appropriate accredited pass); (vii) **Upper Bow**, all sides in its entirety; (viii) **George IV Bridge** (except the extended taxi rank on the **east side** and emergency service vehicles).

(D) from 00:01 hours on 08/08/2023 to 23:59 hours on 13/08/2023 on:

**Johnston Terrace**, *north side*: (1) from a point 230 metres or thereby north-east of its junction with Castle Terrace, eastwards for a distance of 90 metres or thereby (*except authorised event vehicles displaying the appropriate accredited pass*); and (2) from a point 146 metres or thereby south-east of its junction with Castlehill, westwards for a distance of 14 metres or thereby (*except authorised event vehicles displaying the appropriate accredited pass*).

- (E) <u>from 16:00 hours to 23:59 hours (weekdays only) from 03/08/2023 to 17/08/2023; and from 21/08/2023 to 25/08/2023;</u> and
- (F) <u>from 13:15 hours to 23:59 hours on 05/08/2023, 12/08/2023, 18/08/2023, 19/08/2023 and 26/08/2023</u> on:

**King's Stables Road** (except event coaches displaying the appropriate accredited pass).

(G) from 17:00 hours on 02/08/2023 to 23:59 hours on 26/08/2023 on:

**Colinton Road**, *both sides*, from the extended south-western kerbline of Paties Road, south-westwards for a distance of 45 metres or thereby.
