## DEFINITIONS

In this constitution, the following definitions apply throughout:

- "AGM" means an Annual General Meeting.
- "Board" means the Board of Charity Trustees.
- "Charity" means a body entered in the Scottish Charity Register as defined under section 106 of Charities and Trustee Investment (Scotland) Act 2005.
- "Charity Trustees" means the persons having the general control and management of the organisation (The Board).
- "Clauses" means any clause.
- "Clear days" means a period excluding the day when notice is given and the day of the meeting.
- "Community" means the Community area described in Clause 4.
- "GM" means a General Meeting.
- "Group" means those other organisations (incorporated or not) that are not this organisation (SCIO).
- "Individual" means a human/person.
- "Land Reform Act" means the Land Reform (Scotland) Act 2003 and every statutory modification or re-enactment thereof for the time being in force.
- "Members" means those individuals and groups who have joined this organisation.
- "Organisation" means the SCIO whose constitution this relates to.
- "OSCR" Means Office of the Scottish Charity Regulator"
- "Property" means any property, assets or rights, heritable or moveable, wherever situated in the world.
- "SCIO" means Scottish Charitable Incorporated Organisation.
- "Them \& their" means individual or groups (either he, she or they).
- "The 2005 Act" means the Charities and Trustee Investment (Scotland) Act 2005 and

Words importing the singular number only shall include the plural number, and vice versa; and words importing the masculine gender only shall include the feminine gender.

These Clauses supersede any model Clauses and any regulations pertaining thereto. Subject to the aforesaid, any words or expressions defined in the 2005 Act shall, if not inconsistent with the subject or context, bear the same meanings in the Clauses.

The Schedule to these Clauses are deemed to form an integral part of these Clauses.

## General

NAME OF ORGANISATION

| 1 | The name of the organisation is Wester Hailes Growing Communities. |
| :---: | :--- |
| 2 | The organisation will, upon registration, be a Scottish Charitable Incorporated <br> Organisation (SCIO). |

## REGISTERED OFFICE

| 3 | The principal office of the organisation will be in Scotland (and must remain in <br> Scotland). |
| :---: | :--- |

## DEFINITION OF COMMUNITY AND PURPOSES

| 4 | The organisation has been formed to benefit the Community South West <br> Edinburgh as defined by the community council areas of :- <br>  <br>  <br>  <br> - Wester Hailes; <br> - Sighthill, Broomhouse \& Parkhead; <br> - Stenhouse, Saughton Mains \& Whitson; <br> - Hutchinson \& Chesser; and <br> - Longstone |
| :---: | :--- |
| ("the Community"), with the Purposes listed in the sub-clauses hereto ("the <br> Purposes"), to be exercised following the principles of sustainable development <br> (where sustainable development means development which meets the needs of <br> the present without compromising the ability of future generations to meet their <br> own needs), namely: |  |

## PURPOSES

5 The organisation's main purpose is consistent with furthering the achievement of sustainable development. The organisations purposes are:

The advancement of community development (including the advancement of urban regeneration) within the Community.

## POWERS

$6 \quad$ The SCIO has power to do anything which is calculated to further its purposes or is conducive or incidental to doing so.

In particular, (but without limiting the range of powers available under the 2005 Act), the SCIO has power:

| 6.1 | To encourage and develop a spirit of voluntary or other commitment by, or cooperation with, individuals, unincorporated associations, societies, federations, partnerships, corporate bodies, agencies, undertakings, local authorities, unions, co-operatives, trusts and others and any groups or groupings thereof willing to assist the Organisation to achieve the Purposes. |
| :---: | :---: |
| 6.2 | To promote and carry out research, surveys and investigations and to promote, develop and manage initiatives, projects and programmes. |
| 6.3 | To provide advice, consultancy, training, tuition, expertise and assistance. |
| 6.4 | To prepare, organise, promote and implement training courses, exhibitions, lectures, seminars, conferences, events and workshops, to collect, collate, disseminate and exchange information and to prepare, produce, edit, publish, exhibit and distribute clauses, pamphlets, books and other publications, tapes, motion and still pictures, music and drama and other materials, all in any medium. |
| 6.5 | To register an interest in land and to exercise the right to buy land under Part 2 or Part 3A of the Land Reform (Scotland) Act 2003 including any statutory amendment or re-enactment thereof for the time being in force ("the Land Reform Act"). |
| 6.6 | To purchase, take on lease, hire, or otherwise acquire any property suitable for the organisation |
| 6.7 | To construct, convert, improve, develop, conserve, maintain, alter and demolish any buildings or erections whether of a permanent or temporary nature, and manage and operate or arrange for the professional or other appropriate management and operation of the organisation's property. |
| 6.8 | To sell, let, hire, license, give in exchange and otherwise dispose of all or any part of the property of the organisation. |
| 6.9 | To establish and administer a building fund or funds or guarantee fund or funds or endowment fund or funds. |
| 6.10 | To employ, contract with, train and pay such staff (whether employed or selfemployed) as are considered appropriate for the proper conduct of the activities of the organisation. |
| 6.11 | To take such steps as may be deemed appropriate for the purpose of raising funds for the activities of the organisation. |
| 6.12 | To accept subscriptions, grants, donations, gifts, legacies and endowments of all kinds, either absolutely or conditionally or in trust. |
| 6.13 | To borrow or raise money for the Purposes and to give security in support of any such borrowings by the organisation and/or in support of any obligations undertaken by the organisation. |
| 6.14 | To set aside funds not immediately required as a reserve or for specific purposes. |
| 6.15 | To invest any funds which are not immediately required for the activities of the organisation in such investments as may be considered appropriate, which may be held in the name of a nominee organisation under the instructions of the Board of Trustees, and to dispose of, and vary, such investments. |
| 6.16 | To make grants or loans of money and to give guarantees. |


| 6.17 | To establish, manage and/or support any other charity, and to make donations for <br> any charitable purpose falling within the purposes. |
| :---: | :--- |
| 6.18 | To establish, operate and administer and/or otherwise acquire any separate <br> trading organisation or association, whether charitable or not. |
| 6.19 | To enter into any arrangement with any organisation, government or authority <br> which may be advantageous for the purposes of the activities of the organisation <br> and to enter into any arrangement for co-operation, mutual assistance, or sharing <br> profit with any charitable organisation. |
| 6.20 | To enter into contracts to provide services to or on behalf of others. |
| 6.21 | To effect insurance of all kinds (which may include indemnity insurance in respect <br> of Trustees and employees). |
| 6.22 | To oppose, or object to, any application or proceedings which may prejudice the <br> interests of the organisation. |
| 6.23 | To pay the costs of forming the organisation and its subsequent development. |

## GENERAL STRUCTURE OF THE ORGANISATION

| 7 | The structure of the organisation comprises: |
| :---: | :--- |
| 7.1 | Members - comprising: <br> a)Ordinary Members (who have the right to attend the AGM and any GM <br> and have important powers under these Clauses and the Act, who <br> elect people to serve as Trustees and take decisions in relation to any <br> changes to these Clauses), and: <br> b) Associate Members and Junior Members; and <br> 7.2Charity Trustees - comprising: <br> a) Elected Charity Trustees and <br> b) Appointed and/or co-opted Charity Trustees |
| 7.3 | who hold regular meetings between each AGM, in particular, are responsible for <br> monitoring its financial position set the strategy and policy, generally control and <br> supervise the activities of the organisation. |
| 7.4 | The following conditions apply to the structure: |
| 7.5 | The organisation shall have not fewer than 10 members at any time; and <br> Community; and |
| 7.6 | In the event that the number of members falls below 10 or that at least three <br> quarters of the members of the organisation do not consist of members of the |
| Community, the Board may conduct essential business and to ensure the |  |
| admission of sufficient Ordinary Members to achieve the minimum number and/or |  |
| take steps to maintain the majority. |  |

## Membership

MEMBERSHIP

| 8 | The members of the organisation shall consist of those individuals who made the application for registration of the organisation and such other individual or group as are admitted to membership under clauses. |
| :---: | :---: |
| 8.1 | Membership of the organisation is open to: |
| 8.2 | Ordinary Members: those individuals aged 16 and over who: <br> (a) are resident in the Community; and <br> (b) are entitled to vote at a local government election in a polling district that includes the Community or part of it; and <br> (c) who support the purposes; |
| 8.3 | Associate Members: those individuals who: <br> a) are not resident in the Community and those groups wherever located and <br> b) support the purposes. <br> Associate Members are neither eligible to stand for election to the Board nor to vote at any General Meeting. <br> Each member which is a group shall appoint one named Authorised Representative to represent and act for such member at all General Meetings. Any change in the appointment of an Authorised Representative may be made at any time by the appointing member, but only by written notice to the organisation. Such notice will take effect upon its receipt by the organisation. |
| 8.4 | Junior Members: those individuals who: <br> a) are aged between 12 and 15 and <br> b) who support the Purposes. <br> Junior Members are neither eligible to stand for election to the Board nor to vote at any General Meeting. |
| 8.5 | Declaring that, if a member ceases to comply with any of the criteria at Clauses 8.2, 8.3 \& 8.4 they will be obliged to inform the organisation and will thereafter have membership reclassified in terms of either Clauses 8.2, 8.3 or 8.4 and that if the organisation becomes aware of changes itself it will so reclassify the member and notify them accordingly. |

## APPLICATION FOR MEMBERSHIP

9
Any individual or group who wishes to become a member shall in such written form as the Board prescribe submit a written application for membership (in the case of a group the application must be signed by an appropriate officer of that group).
9.1

The Board shall promptly consider applications for membership, made in such written form as it shall prescribe from time to time, determining if the terms of Clause 8.2, 8.3 or 8.4 apply and into which category of membership each applicant shall belong, and immediately thereafter shall approve any valid application provided the applicant is not excluded by virtue of Clause 7.4, 7.5 or 7.6 or has previously been a member of the organisation and continues to be excluded from membership by virtue of Clause 17, and inform the applicant of the board's decision.

## MEMBERSHIP SUBSCRIPTIONS

| 10 | No membership subscription will be payable. |
| :---: | :--- |
| 11 | Membership of the organisation may not be transferred by a member. |

## RE-REGISTRATION OF MEMBERS

| 12 | The Board may, at any time, issue notices to the members requiring them to <br> confirm that they wish to remain as members of the organisation, and allowing <br> them a period of 28 days (running from the date of issue of the notice) to provide <br> that confirmation to the board. |
| :---: | :--- |
| 13 | If a member fails to provide confirmation to the board (in writing or by e-mail) that <br> they wish to remain as a member of the organisation before the expiry of the 28- <br> day period referred to in clause 12, the board may expel them from the <br> membership. |
| 14 | A notice under clause 12 will not be valid unless it refers specifically to the <br> consequences (under clause 13) of failing to provide confirmation within the 28- <br> day period. |

## LIABILITY OF MEMBERS

| 15 | The members of the organisation have no liability to pay any sums to help to meet <br> the debts (or other liabilities) of the organisation if it is wound up; accordingly, if <br> the organisation is unable to meet its debts, the members will not be held <br> responsible. |
| :---: | :---: |
| 16 | The members and Charity Trustees have certain legal duties under the Charities <br> and Trustee Investment (Scotland) Act 2005; and clause 15 does not exclude (or <br> limit) any personal liabilities they might incur if they are in breach of those duties <br> or in breach of other legal obligations or duties that apply to them personally |

## CESSATION OF MEMBERSHIP

| 17 | A member shall cease to be a member if: |
| :---: | :---: |
| 17.1 | Any individual or group who/which wants to withdraw from membership gives <br> a written notice of withdrawal to the organisation, signed by them or (in the <br> case of a group) signed on its behalf by an appropriate officer of that group; <br> they will cease to be a member as from the time when the notice is received <br> by the organisation; or |
| 17.2 | Being a group, it goes into receivership, liquidation, dissolves or otherwise <br> ceases to exist (the right of membership not being assignable); or |


| 17.3 | A resolution that a member be expelled is passed by a majority of at least two <br> thirds of the members present and voting at a General Meeting, of which not <br> less than 21 days' previous notice specifying the intention to propose such <br> resolution and the grounds on which it is proposed shall have been sent to all <br> Charity Trustees, all members and the Office Bearers (if applicable) and also <br> to the member whose removal is in question, such member being entitled to <br> be heard at that meeting; or |
| :---: | :--- |
| 17.4 | Being an individual, they die (the right of membership not being assignable) or |
| 17.5 | Failure to comply with the code of conduct for Trustees which would result in <br> cessation of Trustee and membership; or |
| 17.6 | Failure to respond to any re-registration request under clause 12. |

## REGISTER OF MEMBERS

| 18 | The Board must keep a register of members, setting out for each current member: <br> a) their full name; <br> b) address; and <br> c) the date on which they were registered as a member of the organisation. |
| :---: | :---: |
| 19 | Where any member is not an individual, the register must also contain:  <br> a) Any other name by which the member is known  <br> b)  <br> c) The principle contact for the member; <br> d) Any number assigned to it in the register (if it's a charity); and <br> 20 For each former member - for at least six years from the date on he/she ceased to <br> be a member: <br> a) their name; and  <br> b) the date on which they ceased to be a member  |
| 21 | The Board must ensure that the register of members is updated within 28 days of <br> receiving notice of any change |
| 22 | If a member or Charity Trustee of the organisation requests a copy of the register <br> of members, the Board must ensure that a copy is supplied to them within 28 <br> days, providing the request is reasonable; if the request is made by a member <br> (rather than a Charity Trustee), the Board may provide a copy which has the <br> addresses blanked out. |

## Decision Making By Members

(See also Schedule 1 in Appendix of Constitution)

## ANNUAL GENERAL MEETINGS

| 23 | The Board shall convene an Annual General Meeting (AGM) for all members in <br> each year, at such time as it may determine, although the first AGM need not be <br> held in the first year provided that it be held within 15 months after the date of <br> incorporation of the Organisation. Thereafter, not more than 15 months shall <br> elapse between one AGM and the holding of the next. |
| :---: | :--- |
| 24 | The business of each AGM shall include: |
| a) the report by the Chairperson on the activities of the organisation; |  |
| b) the election of Charity Trustees; |  |
| c) fixing of annual subscriptions (if applicable); |  |
| d) consideration of the accounts of the organisation |  |
| e) the appointment of the auditor (if applicable); and |  |
| f) the report of the auditor (if applicable) |  |

## THE PROVISIONS WITH REGARD TO GENERAL MEETINGS

| 25 | All other meetings for all members, other than AGMs, shall be called General <br> Meetings (GM); |
| :---: | :---: |
| 26 | The Board may convene a GM whenever it thinks fit; and: |
| 26.1 | The Board must convene a GM within 28 days of a valid requisition. To be <br> valid, such requisition must be signed by not less than 5\% of the ordinary <br> members, must clearly state the purposes of the meeting and must be <br> delivered to the Registered Office. |
| 27 | Subject to the terms of clause 91, the provisions regarding notice of a Meeting are <br> as follows: |
| 27.1 | At least 14 "clear days" notice must be given of any GM or any special <br> members' meeting. |
| 27.2 | The notice calling a members' meeting must specify in general terms what <br> business is to be dealt with at the meeting; and <br> a)in the case of a resolution to alter the constitution, must set out the exact <br> terms of the proposed alteration(s); or <br> b)in the case of any other resolution falling within clause 35 (requirement for <br> two-thirds majority) must set out the exact terms of the resolution |
| 27.3 | Any notice which requires to be given to a member under this constitution <br> must be: - <br> a) sent by post to the member, at the address last notified by them to the <br> organisation; or <br> b) sent by e-mail to the member, at the e-mail address last notified by <br> them to the organisation | organisation, and to all the Charity Trustees; but the accidental omission to give notice to one or more members will not invalidate the proceedings at the meeting.

## CHAIRPERSON OF MEETINGS (AGM \& GM)

28 The Chairperson of the organisation shall act as Chairperson of each meeting or if not present or willing the Vice-Chairperson of the organisation shall act as Chairperson of each meeting. If neither the Chairperson nor the Vice-Chairperson is present or willing to act as Chairperson of the meeting within 15 minutes after the time at which the General Meeting in question was due to commence, the Charity Trustees present shall elect from among themselves one of the Elected Charity Trustees who will act as Chairperson of that meeting.

## QUORUM AT GENERAL MEETINGS

| 29 | The quorum for a general meeting shall be the greater of (a) 8 Ordinary Members <br> or (b) $10 \%$ of the Ordinary Members, in either event being present in person or by <br> proxy. No business shall be dealt with at any general meeting unless a quorum is <br> present. |
| :---: | :--- |
| 30 | If a quorum is not present within 15 minutes after the time at which the general <br> meeting was due to commence - or if, during a general meeting, a quorum ceases <br> to be present - the general meeting shall stand adjourned to such time, date and <br> place as may be fixed by the Chairperson of the general meeting. |
| 31 | The board may make any arrangements in advance of any general meetings to <br> allow members to fully participate in such general meetings so long as all those <br> participating in the meeting can clearly comprehend each other; a member <br> participating in any such means other than in person shall be deemed to be <br> present in person at the general meeting. |

## VOTING AT GENERAL MEETINGS

| 32 | The Chairperson of the meeting shall endeavour to achieve consensus wherever <br> possible but, if necessary, questions arising shall be decided by being put to the <br> vote. |
| :---: | :---: |
| 33 | The provisions regarding voting are as follows: |
| 33.1 | a) <br> b) each Ordinary Member shall have one vote, to be exercised in person or <br> by proxy, by a show of hands <br> Unless a secret ballot is demanded by the Chairperson of the meeting, or <br> by at least two Ordinary Members present at the meeting and entitled to <br> vote, this may be demanded only before any show of hands takes place <br> and shall be taken immediately at the same meeting. <br> c) |
| This shall be conducted in such a manner as the Chairperson of the <br> meeting may direct and the result of which shall be declared at the same <br> meeting at which the ballot was demanded. <br> In that event, the Chairperson of the meeting shall appoint and instruct <br> tellers, who may cast their own personal votes if Ordinary Members; |  |
| 33.2 | Associate and Junior Members shall have no vote; |


| 33.3 | Whilst actual attendance by Ordinary Members is to be encouraged at <br> General Meetings, any Ordinary Member shall be entitled to complete one <br> form of proxy to appoint a proxy to attend a General Meeting on their behalf, <br> in respect of which the following apply: |
| :---: | :---: |
| 33.3 .1 | a proxy need not be a member; |
| 33.3 .2 | a proxy appointed to attend and vote at any meeting instead of an Ordinary <br> Member shall have the same right as the Ordinary Member who appointed <br> him or her to speak at the meeting and to vote thereat; and |
| 33.3 .3 | the form appointing the Proxy shall be in terms of Schedule 1 annexed to <br> these Clauses; |
| 33.3 .4 | the form appointing a proxy and the power of attorney or other authority (if <br> any) under which it is signed, or a certified copy thereof, shall be lodged at <br> the Registered Office not less than 48 hours before the time of the meeting <br> at which the proxy is to be used; and |
| 33.3 .5 | no form of proxy shall be valid more than 12 months from the date it was <br> granted; and |
| 33.4 | in the event of an equal number of votes for and against any resolution, the <br> Chairperson of the meeting shall have a vote in their capacity as a member of the <br> organisation |

## RESOLUTIONS

| 34 | Ordinary and Special Resolutions may be passed in writing, rather than at a <br> General Meeting provided that the terms of Clause 35 are followed: |
| :---: | :--- |
| 35 | At any General Meeting a resolution put to the vote of the meeting shall be voted <br> upon by a simple majority of the Ordinary Members who are present and voting <br> thereon, except for decisions relating to any of the following Special Resolutions, |
| a) to alter the name of the Organisation; or |  |
| b) to amend the Purposes; or |  |
| c) to amend these Clauses or |  |
| d) to wind up of the Organisation in terms of Clause 94; or |  |
| e) all other Special Resolutions. |  |
| shall require to be decided upon by not less than two thirds of the Ordinary |  |
| Members present and voting thereon (no account therefore being taken of |  |
| members who abstain from voting or who are absent from the meeting). |  |


| 35. | Where such a written resolution is proposed by members, the following shall <br> apply: <br> (a) the resolution must be requested by not less than $5 \%$ of the voting members <br> ("the members request"); <br> (b) the members' request must identify the resolution to be put to members and <br> the Board can reject such resolutions, but must provide reasons for doing so <br> to the members requesting the resolution; <br> (c) within 14 days, the Board must circulate (circulation date) the resolution with <br> the express statements referred to: |
| :---: | :---: |
| 1. An explanation to the eligible members how to signify their agreement to the <br> resolution; <br> 2. how it can be sent back by them, <br> 3. clarification that a failure to reply will be deemed to be a vote against the <br> resolution in question; |  |
| 35.1 | 4. and the date by which the resolution must be passed if it is not to lapse (that <br> is, the date which is 28 days after the Circulation Date). |
| An ordinary resolution in writing signed by or on behalf of a simple majority of <br> all the Ordinary Members shall be as valid and effective as if the same had <br> been passed at a General Meeting of the organisation duly convened and <br> held, provided that the terms of this Clause are followed. |  |
| 35.2 | A Special Resolution in writing signed by or on behalf of not less than two <br> thirds of all the Ordinary Members shall be as valid and effective as if the <br> same had been passed at a General Meeting of the organisation duly <br> convened and held, provided that the terms of this Clause are followed. |

## MEETING ADJOURNMENT

 Ordinary Members present and voting thereat, adjourn the General Meeting to such time, date and place as he or she may determine.
## ORGANISATION MANAGEMENT

The affairs, property and funds of the organisation shall be directed and managed by a Board of Charity Trustees. The Board may exercise all such powers of the organisation, and may on behalf of the organisation do all acts as may be exercised and done by the organisation, other than those required to be exercised or done by the Ordinary Members in a General Meeting, and subject always to these Clauses and to the provisions of the 2005 Act.

## Board of Trustees

(See also Clauses 78, 79 \& 80)

## INTERIM BOARD

38 Upon incorporation of the organisation, the following applies with regard to the Interim Board of Charity Trustees:
38.1 The individuals who signed the Charity Trustee declaration forms which accompanied the application for incorporation of the organisation shall be deemed to have been appointed by the members as Charity Trustees with effect from the date of incorporation of the organisation'.

## ELECTED CHARITY TRUSTEES

| 42 | At the first General Meeting held in terms of Clause $\mathbf{3 8 . 2}$ and 40, the Ordinary <br> Members shall elect up to 10 Elected Charity Trustees, in respect of which the <br> following shall apply: |

| 42.1 | Provided that the first General Meeting in terms of Clause 38.2 is held before the <br> first AGM, there shall be no change in or election of Charity Trustees at the first <br> AGM (except to the extent of filling any vacancies in the Board left over after the <br> first General Meeting or caused by any retirals since); |
| 42.2 | At the second and each subsequent AGM, one-third of the Elected Charity <br> Trustees (or the nearest number upwards) shall retire from office; |
| 42.3 | A retiring Elected Charity Trustee shall retain office until the close or <br> adjournment of the meeting; |
| 42.4 | A retiring Elected Charity Trustee shall be eligible for re-election; |


| 42.5 | If no other Charity Trustee has or Charity Trustees have decided or agreed to <br> retire, the Elected Charity Trustees to retire at each AGM shall be those who <br> have been longest in office since their lat election but, as between persons <br> who were elected or last re-elected Charity Trustees on the same day, the one <br> or ones to retire shall (unless they otherwise agree amongst themselves) be <br> determined by lot; |

## CO-OPTED CHARITY TRUSTEES

| 43 | Subject to Clause 40.2, up to 4 individual/individuals may be co-opted from time <br> to time by the Board of Trustees itself, as follows: |

| 43.1 | subject to Clause 43.3, a Co-opted Charity Trustee shall serve until the next <br> AGM after his or her co-option; |

## VACANCY \& JUNIOR REPRESENTATION ON BOARD

| 44 | The Board may from time to time fill any casual vacancy arising as a result of the <br> retiral (or deemed retiral for any reason) of any Elected Charity Trustee from or <br> after the date of such retiral or deemed retiral until the next AGM. |

## CHARITY TRUSTEES - GENERAL DUTIES

| 45 | Each of the Charity Trustees has a duty, in exercising functions as a Charity <br> Trustee, to act in the interests of the organisation; and, in particular, must:- |

| 45.1 | seek, in good faith, to ensure that the organisation acts in a manner which is <br> in accordance with its purposes; |
| 45.2 | act with the care and diligence which it is reasonable to expect of a person <br> who is managing the affairs of another person; |

| 45.4 | ensure that the organisation complies with any direction, requirement, notice <br> or duty imposed under or by virtue of the Charities and Trustee Investment <br> (Scotland) Act 2005 |
| 46 | In addition to the duties outlined in clause 45, all of the Charity Trustees must <br> take such steps as are reasonably practicable for the purpose of ensuring: - |
| 46.1 | that any breach of any of those duties by a Charity Trustee is corrected by the <br> Charity Trustee concerned and not repeated; and |
| 46.2 | that any Charity Trustee who has been in serious and persistent breach of <br> those duties is removed as a Charity Trustee. |

## CODE OF CONDUCT FOR CHARITY TRUSTEES

| 47 | Each of the Charity Trustees shall comply with the code of conduct (incorporating <br> detailed rules on conflict of interest) prescribed by the board from time to time. |

b) The address of the Charity Trustee
c) the date on which they were appointed as a Charity Trustee; and
d) any office held by them in the organisation;

| 50 | Where a Charity Trustee is not an individual the register must also contain <br> a) Any other name by which the Charity Trustee is known <br> b) The principle contact for the Charity Trustee <br> c) Any number assigned to it in the register (if it's a charity) <br> d) Any number with which it is registered as a company |

| 53 | The Board must ensure that the register of Charity Trustees is updated within 28 days of receiving notice of any change |
| 54 | If any person requests a copy of the register of Charity Trustees, the Board must ensure that a copy is supplied to him/her within 28 days, providing the request is reasonable; if the request is made by a person who is not a Charity Trustee of the organisation, the board may provide a copy which has the addresses blanked out - if the organisation is satisfied that including that information is likely to jeopardise the safety or security of any person or premises. |

## TERMINATION OF CHARITY TRUSTEES OFFICE

$55 \quad$ A Charity Trustee will automatically cease to hold office if: -
a) they become disqualified from being a Charity Trustee under the Charities and Trustee Investment (Scotland) Act 2005;
b) they become incapable for medical reasons of carrying out his/her duties as a Charity Trustee - but only if that has continued (or is expected to continue) for a period of more than six months;
c) in the case of a Charity Trustee elected under clause 42) they ceases to be a member of the organisation;
d) in the case of a Charity Trustee co-opted under clauses 43) the board under clause 44.3 vote to end the appointment;
e) they becomes an employee of the organisation;
f) they gives the organisation a notice of resignation, signed by them;
g) they are absent (without good reason, in the opinion of the board) from more than three consecutive meetings of the board - but only if the board resolves to remove him/her from office;
h) they are removed from office by resolution of the board on the grounds that they are considered to have committed a material breach of the code of conduct for Charity Trustees (as referred to in clauses 45 to 48);
i) they are removed from office by resolution of the board on the grounds that they are considered to have been in serious or persistent breach of his/her duties under section 66(1) or (2) of the 2005 Act; or
j) they become prohibited from being a Charity Trustee by virtue of section 69(2) of the 2005 Act
k) they commit any offence under section 53 of the 2005 Act.

| 56 | Subject to clause 55(h) the Charity Trustee who is subject of the resolution is <br> given reasonable prior written notice of the grounds upon which the resolution for <br> removal is to be proposed. |

| 56.1 | The Charity Trustee concerned is given the opportunity to address the <br> meeting at which the resolution is proposed prior to the resolution being put to <br> a vote. |
| 56.2 | In the case of a resolution under clause $\mathbf{5 5 ( h )}$ at least two thirds of the Charity <br> Trustees then in office a required to vote in favour of the resolution. |

## RETIRAL OF CHARITY TRUSTEES

57 Subject to Clause 42.2 at the second and each subsequent AGM, one-third of the Elected Charity Trustees (or the nearest number upwards) shall retire from office;

## CHAIRPERSON AND VICE-CHAIRPERSON

| 58 | The Board shall meet as soon as practicable immediately after each AGM (or <br> after a resignation of the Chairperson or Vice-Chairperson) meet to appoint a <br> Chairperson, and if desired a Vice-Chairperson, from the Charity Trustees (both of <br> whom must be Ordinary Members). |

## BOARD MEETING VOTING

| 70 | The Chairperson, whom failing the Vice-Chairperson (if any), shall be entitled to <br> preside as Chairperson of all Board meetings at which he or she is present. If at <br> any meeting neither the Chairperson nor the Vice-Chairperson is present and <br> willing to act as Chairperson of the meeting within 15 minutes after the time <br> appointed for holding the meeting, the remaining Charity Trustees may appoint <br> one of the Elected Charity Trustees to be Chairperson of the Board meeting, <br> which failing the meeting shall be adjourned until a time and date when the <br> Chairperson or Vice-Chairperson will be available. |

| 72 | Each Charity Trustee present (and is eligible to vote) has one vote. In the event of <br> an equal number of votes for and against any resolution at a Board meeting, the <br> Chairperson of the meeting shall have a casting vote as well as a deliberative <br> vote. |

## MINUTES

| 73 | The Board shall cause minutes to be made of all appointments of officers made <br> by it and of the proceedings of all General Meetings and of all Board meetings <br> and of sub-committees, including the names of those present, and all business <br> transacted at such meetings and any such minutes of any meeting, if purporting to <br> be signed after approval, either by the Chairperson of such meeting, or by the <br> Chairperson of the next succeeding meeting, shall be sufficient evidence without <br> any further proof of the facts therein stated. |

## SUB-COMMITTEES

74 The Board may delegate any of its powers to sub-committees, each consisting of not less than one Charity Trustee and such other person or persons as it thinks fit or which it delegates to the committee to appoint. Any sub-committee so formed shall, in the exercise of the powers so delegated, conform to any remit and regulations imposed on it by the Board. The meetings and proceedings of any such sub-committee shall be governed by the provisions of these Clauses for regulating the meetings and proceedings of the Board so far as applicable and so far as the same shall not be superseded by any regulations made by the Board. Such sub-committee shall regularly and promptly circulate, or ensure the regular and prompt circulation of, the minutes of its meetings to all Charity Trustees.

## CONSTRAINTS ON PAYMENTS/BENEFITS TO MEMBERS AND CHARITY TRUSTEES

## DISSOLUTION
