The title of the Order is "The City of Edinburgh Council (Canaan Lane, Merchiston Avenue, Summerfield Place, East Hermitage Place and Yeaman Place, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 202_" - RSO/22/07. A copy of the proposed Order and of the accompanying plans showing the roads over which the means of exercise of the public right of passage is to be redetermined, together with a statement of the reasons for making the Order can be viewed free of charge between 9:30 to 15:30 Mon-Fri from 11/08/23 to 08/09/23 at Waverley Court Reception or online during the same period at www.edinburgh.gov.uk/trafficorders and www.tellmescotland.gov.uk. SCHEDULE 1 ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO FOOTWAY Summerfield Pl & East Hermitage Pl (i) All that part of the carriageway on the west side of Summerfield Pl and the south side of East Hermitage Pl, from the intersection of the southern kerbline of East Hermitage Pl and the western kerbline of Summerfield Pl, southwards for a distance of 10m or thereby and has a width that varies from 1m or thereby to 0m or thereby. Merchiston Ave & Yeaman Pl (i) All that part of the carriageway on the east side of Yeaman Pl and the north side of Merchiston Ave from a point 4m or thereby north of the intersection of the eastern kerbline of Yeaman Pl and the northern kerbline of Merchiston Ave: (a) southwards for a distance of 5.4m or thereby and has a width that varies from 0m or thereby to 2.8m or thereby, then (b) eastwards for a distance of 7.2m or thereby and has a width that varies from 2.8m or thereby to 1.2m or thereby, then (c) eastwards for a distance of 1.2m or thereby and has a width that varies from 1.2m or thereby to 0m or thereby. (ii) All that part of the carriageway on the east side of Yeaman Pl and the south side of Merchiston Ave from a point 4.2m or thereby south of the intersection of the eastern kerbline of Yeaman Pl and the southern kerbline of Merchiston Ave: (a) northwards for a distance of 5.7m or thereby and has a width that varies from 0m or thereby to 2.5m or thereby, then (b) eastwards for a distance of 7.1m or thereby and has a width that varies from 2.5m or thereby to 1.3m or thereby, then (c) eastwards for a distance of 1.2m or thereby and has a width that varies from 1.3m or thereby to 0m or thereby. Canaan La (i) All that part of the carriageway on the east side of Canaan La (at the most south-eastern access to Astley Ainslie Hospital), from a point 0.3m or thereby south of the extended northern boundary at the rear of the footway, southwards for a distance of 3m or thereby and has a width that varies from 0m or thereby to 5.4m or thereby. (ii) All that part of the carriageway on the east side of Canaan La (at the most south-eastern access to Astley Ainslie Hospital), from a point 0.7m or thereby northwest of the intersection of the boundary at the rear of the footway and the northeastern kerbline of the entrance to the unnamed access road to the Astley Ainslie Hospital: (a) north-westwards for a distance of 3.1m or thereby and has a width that varies from 0m or thereby to 1.9m or thereby, then (b) northwards for a distance of 9.7m or thereby and has a width that varies from 1.9m or thereby to 0m or thereby. (iii) All that part of the carriageway on the south side of Canaan La (at the most southeastern access to Astley Ainslie Hospital), from the intersection of the boundary at the rear of the footway and the south-western kerbline of the entrance to the unnamed access road to the Astley Ainslie Hospital, north-westwards and then westwards for a distance of 14.9m or thereby and has a width that varies from 0m or thereby to 2.5m or thereby. (iv) All that part of the carriageway on the south side of Canaan La (at the most south-eastern access to Astley Ainslie Hospital), from a point 26.8m or thereby north-west and then west of the intersection of the boundary at the rear of the footway and the south-western kerbline of the entrance to the unnamed access road to the Astley Ainslie Hospital, westwards for a distance of 15.2m or thereby and has a width that varies from 0m or thereby to 0.8m or thereby. (v) All that part of the carriageway of the north side of Canaan La (opposite the south-eastern access to Astley Ainslie Hospital), from a point 3m or thereby north-east of the extended south-western kerbline of the entrance to the unnamed access road to Astley Ainslie Hospital, southwestwards for a distance of 9.4m or thereby and has a width that varies from 0m or thereby to 0.5m or thereby. Yeaman Pl (i) All that part of the carriageway on the east side of Yeaman Pl, from the intersection of the northern kerbline of the entrance to 23 Yeaman Pl and the eastern kerbline of Yeaman Pl, northwards: (a) for a distance of 2.3m or thereby and has a width that varies from 0m or thereby to 1.9m or thereby, then (b) for a distance of 2m or thereby and has a width of 1.9m or thereby to 0m or thereby. (ii) All that part of the carriageway on the east side of Yeaman Pl, from the intersection of the southern kerbline of the entrance to 23 Yeaman Pl and the eastern kerbline of Yeaman Pl, southwards: (a) for a distance of 2.3m or thereby and has a width that varies from 0m or thereby to 1.9m or thereby, then (b) for a distance of 2m or thereby and has a width of 1.9m or thereby to 0m or thereby. **SCHEDULE 2** ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM FOOTWAY TO CARRIAGEWAY Canaan La (i) All that part of the footway on the east side of Canaan La (at the most south-eastern access to Astley Ainslie Hospital), from a point 5.4m or thereby east of a point 3.3m or thereby south of the extended northern boundary at the rear of the footway, southeastwards for a distance of 1.7m or thereby and has a width that varies from 0m or thereby to 1.3m or thereby. (ii) All that part of the footway on the south side of Canaan La (at the most south-eastern access to Astley Ainslie Hospital), from a point 21.4m or thereby north-west and then west of the intersection of the boundary at the rear of the footway and the south-western kerbline of the entrance to the unnamed access road to the Astley Ainslie Hospital, westwards for a distance of 5.4m or thereby and has a width that varies from 0m or thereby to 0.8m or thereby. (iii) All that part of the footway of the north side of Canaan La (opposite the south-eastern access to Astley Ainslie Hospital), from a point 6.4m or thereby south-west of the extended south-western kerbline of the entrance to the unnamed access road to Astley Ainslie Hospital, south-westwards for a distance of 4.9m or thereby and has a width that varies from 0m or thereby to 0.3m or thereby.
