

## ROADS (SCOTLAND) ACT 1984

The City of Edinburgh Council proposes to make an Order under sections 1(1) and 152(2) of the Roads (Scotland) Act 1984 redetermining the roads described in the Schedule hereto. The title of the Order is "The City of Edinburgh Council (Brunstane and Coillesdene Area, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 202-" - RSO/23/15. A copy of the proposed Order and of the accompanying plans showing the roads over which the means of exercise of the public right of passage is to be redetermined, together with a statement of the reasons for making the Order can be viewed free of charge, between 9:30 to 15:30 Mon-Fri from 18/08/23 to 15/09/23 at Waverley Court Reception or online during the same period at [www.edinburgh.gov.uk/trafficorders](http://www.edinburgh.gov.uk/trafficorders) and [www.tellmescotland.gov.uk](http://www.tellmescotland.gov.uk). ### **SCHEDULE 1** ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO FOOTWAY

**Milton Dr and Seaview Cres** All that part of the carriageway on the sth-east side of Milton Dr at Seaview Cres from a point 5.8m or thereby sth of the extended sth kerbline of Seaview Cres northwards then eastwards to a point 5.5m or thereby east of the extended east kerbline of Milton Dr and which has a width that varies from 0m or thereby to 1.7m or thereby. **Milton Terr and Coillesdene Ave** All that part of the carriageway on the sth-east side of Milton Terr at Coillesdene Ave from a point 6.4m or thereby sth-east of the extended sth-east kerbline of Coillesdene Ave nth-westwards and then nth-eastwards to a point 5.6m or thereby nth-east of the extended nth-east kerbline of Milton Terr and which has a width that varies from 0m or thereby to 1.85m or thereby. **Milton Rd East, Coillesdene Cres and Coillesdene Gdns a)** All that part of the carriageway on the nth-west side of Milton Rd East at its junction with Coillesdene Cres and Coillesdene Gdns from a point 18.6m or thereby sth-west of the extended sth-west kerbline of Coillesdene Cres nth-eastwards and then northwards to a point 11m or thereby northwest of the extended northwest kerbline of Milton Rd East and which has a width that varies from 0m or thereby to 6.45m or thereby. **b)** All that part of the carriageway on the nth-east side of Milton Rd East at its junction with Coillesdene Cres and Coillesdene Gdns from a point 13.4m or thereby nth-east of the extended east kerbline of Coillesdene Gdns sth-westwards and then northwards to a point 8.17m or thereby nth of the extended nth-west kerbline of Milton Rd East and which has a width that varies from 0m or thereby to 6.3m or thereby. **Milton Rd East and Milton Dr** All that part of the carriageway on the nth-west side of Milton Rd East at its junction with Milton Dr from a point 5.6m or thereby sth-west of the extended west kerbline of Milton Dr, nth-eastwards and then northwards to a point 5.05m or thereby nth of the extended nth-west kerbline of Milton Rd East and which has a width that varies from 0m or thereby to 1.65m or thereby.
