THE CITY OF EDINBURGH COUNCIL (RIDING OF THE MARCHES) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/203

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other enabling powers being satisfied that traffic on the lengths of roads specified in the Schedules hereto should be prohibited or restricted to facilitate public safety during the Riding of the Marches event, and to enable members of the public to watch this event and being satisfied that it is not reasonably practicable for the event to be held otherwise than on a road and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, with the consent of the Scottish Ministers under section 16B(1)(b) and 16B(6)(b) of the said Act, hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Riding of the Marches) (Temporary Road Restriction and Traffic Regulation) Order 2023". The Order shall have effect during the hours and on the dates specified in the Schedules to this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "event vehicle" means any vehicle authorised by City of Edinburgh Council as being connected with the event;
 - "motor vehicle" has the same meaning as in Section 136 of the 1984 Act;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
 - "Schedule" means a Schedule to this Order;
 - "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4 of this Order, to facilitate public safety during the Riding of the Marches event (as signed as affected by the event), no person shall:-
 - (a) cause or permit any motor vehicle to enter, proceed or wait in or on any part of the lengths of roads specified in Schedule 1 hereto, where prohibitions will apply to roads in their entirety unless otherwise stated;
 - (b) drive or cause or permit to be driven any motor vehicle on the sections of roads specified in column 1 of Schedule 2, otherwise than in the direction specified in column 2 of Schedule 2 hereto; and
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads described in Schedule 3 hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.
- 4. Nothing in:
 - (i) Article 3 shall apply to emergency service vehicles;
 - (ii) Articles 3(a) and (b) shall apply to *event vehicles* on the sections of roads specified in Schedules 1 and 2.
- 5. The 2018 Order will be suspended in so far as it is affected by the measures described in Article 3(c) of this Order.

- 6. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading: City Centre) (No. 1) Experimental Traffic Order 2022' will be suspended *between* 10:30 hours and 18:00 hours on 10/09/2023 in relation to the *prohibition of waiting, loading & unloading, prohibition of motor vehicles and one-way restriction* on **High Street**, to facilitate the holding of the Riding of the Marches event.
- 7. The restrictions imposed by Article 3 in this Order shall repeal any existing provision, restriction or requirement imposed by any regulations made or having effect as if made under Section 14 or 16 of the Road Traffic Regulation Act 1984, as amended, as aforesaid or by or under any other enactment, whilst the provisions of this Order are in operation in accordance with Article 3 of this Order.
- 8. The alternative route for through vehicular traffic will be by way of Calton Road, Cowgate, Leith Street, Blair Street, Jeffrey Street, North Bridge, Princes Street, South Bridge and St Mary's Street.

SCHEDULE 1 PROHIBITION OF MOTOR VEHICLES

(A) from 09:00 hours to 12:15 hours on 10/09/2023 on:

- (i) Gilmerton Road, between its junction with the roundabout at the City Bypass and its junction with Gilmerton Station Road; (ii) Gilmerton Station Road; (iii) Lasswade Road, between its junction with Gilmerton Station Road and its junction with Captain's Road; (iv) Captain's Road; (v) Alnwickhill Road, between its junction with Howden Hall Road and its junction with Stanedykehead; (vii) Mounthooly Loan, between its junction with Frogston Road West and its junction with Galachlawside; (viii) Frogston Road West, between its junction with Winton Drive and its junction with Frogston Brae; (ix) Frogston Brae; (x) Frogston Road East; and (xi) Lang Loan.
- (B) from 10:30 hours to 18:00 hours on 10/09/2023 on:
- (i) **High Street**, between its junction with North Bridge and its junction with Lawnmarket; (ii) **Lawnmarket**, between its junction with High Street and its junction with George IV Bridge; (iii) **West Parliament Square**; (iv) **Parliament Square**; and (v) **St Giles' Street**.
- (C) from 14:00 hours to 16:00 hours on 10/09/2023 on:
- (i) **Ferniehill Road**, between its junction with Old Dalkeith Road and its junction with Moredun Park Road; (ii) **Moredun Park Road**, between its junction with Ferniehill Road and its junction with Craigour Avenue; (iii) **Craigour Avenue**; (iv) **Craigour Drive**, between its junction with Craigour Avenue and its junction with Moredunvale Road; (v) **Moredunvale Road**, between its junction with Craigour Drive and its junction with Old Dalkeith Road; (vi) **Old Dalkeith Road**, between its junction with Moredunvale Road and its junction with Craigmillar Castle Road; (vii) **Craigmillar**

Castle Road; (viii) **Castlebrae Avenue**, between its junction with Castlebrae Wynd and its junction with Craigmillar Castle Road; (ix) **Duddingston Road West**, between its junction with Niddrie Mains Road and its junction with Old Church Lane; and (x) **Old Church Lane**.

(A) <u>from 09:00 hours on 08/09/2023 to 10:29 hours on 10/09/2023; and from 18:01 hours on 10/09/2023 to 16:00 hours on 11/09/2023</u> on:

Parliament Square, *east side*, from a point 22 metres or thereby south of the extended southern kerbline of High Street, generally southwards for a distance of 21 metres or thereby.

- (B) from 06:00 hours to 18:00 hours on 10/09/2023 on:
- (i) **King's Stables Road**; (ii) **Johnston Terrace**, *north side*, from the westernmost extent of Castle Wynd North steps, eastwards for a distance of 62 metres or thereby; (iii) **West Port** (*except recessed bays*); and (iv) **East Fountainbridge** (*except recessed bays*).

- (C) <u>from 10:30 hours to 18:00 hours on 10/09/2023</u> on:
