THE CITY OF EDINBURGH COUNCIL (DEVON PLACE) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2023 – TEMP/23/212

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Devon Place) (Temporary Road Restriction and Traffic Regulation) Order 2023” and shall come into operation on the Twenty-fourth day of October Two thousand and twenty-three. The City of Edinburgh Council is satisfied that the execution of the works referred to in this Order will take in excess of eighteen months.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“motor vehicle” has the same meaning as in Section 136 of the 1984 Act
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4 of this Order, to facilitate a site compound (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit any motor vehicle to be driven on **Devon Place**, from the extended northern kerbline of Devon Place (*east-west section*), northwards to its junction with West Coates, otherwise than in a **northbound** direction; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on **Devon Place, both sides**, from the extended northern kerbline of Devon Place (*east-west section*), northwards to its junction with West Coates.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
6. ‘The City of Edinburgh Council (Greenways) Order 1997’, as amended, will be suspended in relation to the *no stopping or loading at any time restrictions* on the affected section of **Devon Place**, to facilitate the site compound.

7. The alternative route for through vehicular traffic with respect to the *one-way restriction* will be by way of West Coates, Stanhope Street, Stanhope Place and Devon Place.
