THE CITY OF EDINBURGH COUNCIL (BRAIDBURN AREA, EDINBURGH)
(REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE) ORDER
2023 - RSO/23/22

The City of Edinburgh Council, in exercise of the powers conferred on them by section 1(1) and 152 (2) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, hereby make the following Order:-

- 1. This Order may be cited as "The City of Edinburgh Council (Braidburn Area, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 2023" and shall come into operation on the thirteenth day of November Two thousand and twenty-three.
- 2. The roads in the City of Edinburgh local government area specified in Schedule 1 to this Order, at present carriageway, shall become cycle track footway, the right of passage being exercisable by pedal cycle and foot only.
- 3. The roads in the City of Edinburgh local government area specified in Schedule 2 to this Order, at present footway, shall become cycle track footway, the right of passage being exercisable by pedal cycle and foot only.
- 4. The roads in the City of Edinburgh local government area specified in Schedule 2 to this Order, at present footway, shall become carriageway, the right of passage being exercisable by all classes of traffic.

Greenbank Crescent

a) All that part of the carriageway on the south side of Greenbank Crescent and the west side of Comiston Road from a point 28.74 metres or thereby west of the intersection of the south kerbline of Greenbank Crescent and the west kerbline of Comiston Road, eastwards and then southwards to a point 8.45 metres or thereby south of the said intersection and which has a width that varies from 0 metres or thereby to 2.64 metres or thereby. (marked Area A1 on the attached plans)

Braidburn Terrace (South Side)

- a) All that part of the carriageway on the south side of Braidburn Terrace and the east side of Comiston Road from a point 29.99 metres or thereby east of the intersection of the south kerbline of Braidburn Terrace and the east kerbline of Comiston Road, westwards and then southwards to a point 13.10 metres or thereby south of the said intersection and which has a width that varies from 0 metres or thereby to 3.70 metres or thereby. (marked Area A3 on the attached plans)
- b) All that part of the carriageway on the south side of Braidburn Terrace and the west side of Braid Road from a point 15.23 metres or thereby west of the intersection of the south kerbline of Braidburn Terrace and the west kerbline of Braid Road, eastwards and then southwards to a point 7.61 metres or thereby south of the said intersection and which has a width that varies from 0 metres or thereby to 6.39 metres or thereby. (marked Area A8 on the attached plans)

a) All that part of the carriageway on the north side of Hermitage Drive and the east side of Braid Road from a point 25.96 metres or thereby east of the intersection of the north kerbline of Hermitage Drive and the east kerbline of Braid Road, westwards and then northwards to a point 19.69 metres or thereby north of the said intersection and which has a width that varies from 0 metres or thereby to 5.88 metres or thereby.

(South Side)

a) All that part of the carriageway on the south side of Hermitage Drive and the east side of Braid Road from a point 24.43 metres or thereby east of the intersection of the south kerbline of Hermitage Drive and the east kerbline of Braid Road, westwards and then southwards to a point 7.70 metres or thereby south of the said intersection and which has a width that varies from 0 metres or thereby to 7.06 metres or thereby.

Hermitage Drive

(Traffic island on the north side of the road)

a) All that part of the footway on the traffic island on the north side of Hermitage Drive from the most northern point of the said traffic island, southwards for a distance of 0.97 metres or thereby and which has a width that varies from 0 metres or thereby to 1.96 metres or thereby. (marked Area A15 on the attached plans)
