## The City Of Edinburgh Council (Traffic Regulation; Restrictions On Waiting, Loading and Unloading, and Parking Places) (Variation No \_) Order 202 -TRO/23/37

The Council proposes to make an Order under the Road Traffic Regulation Act 1984 as amended to: 1. Introduce 24hr waiting restrictions on a) Longstone Gdns; b) Longstone Vw, c) Sighthill Terr at Sighthill Ln, d) Drum Cottages at Drum St, e) Bankhead Dr at Bankhead Crossway Sth, f) Bankhead Dr at Bankhead Way, g) Kirklands Pk St at Maude Cl, h) Kirklands Pk St west of its junction with Maude Pl, i) Gt Michael Rise, j) Deanpark Pl at Deanpark Ave, k) Young Dr at Ferrymuir, l) Annfield St, m) Connaught Pl, n) St Ninians Rd at Forrester Rd, o) Rattray Dr at Littlejohn Ave, p) Bankhead Broadway, q) Marionville Gr at Marionville Dr, r) Boswall Parkway at Boswall Dr, s) Deanpark Gr at Deanpark Ave, t) Drum Brae Dr, u) Drum Brae Sth & Drum Brae Nth at Drum Brae Dr, v) Telford Rd (Access Rd to no. 79-87), w) Oxgangs Ave west of its junction with Oxgangs Cres, x) Stanley Rd west of its junction with Newhaven Rd, y) Stanley Rd op 1, z) Templeland Rd east of its junction with Drum Brae Sth.

**2.** Introduce new 24hr waiting and loading prohibitions at a) Pavillion Cres (at the far eastern extent), b) Pavillion Cres at East Suffolk Rd (both sides), c) Caiystane Cres west of its junction with Buckstone Terr.
