

The City of Edinburgh Council in exercise of their powers under sections 1(1), 2(1) to (3), 32, 35, 45, 46, 49 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended (which Act as so amended is hereinafter referred to as "the 1984 Act") and of all other enabling powers, being satisfied that for facilitating the passage of vehicular traffic on the roads to which this Order relates it is requisite that section 3(1) of the 1984 Act should not apply in relation to this Order, and after consultation with the Chief Constable in accordance with Part III of Schedule 9 of the 1984 Act and with the consent of the Secretary of State for Scotland given under Part II of Schedule 9 to the 1984 Act, hereby make the following Order:-

CITATION AND COMMENCEMENT

- 1 (1) This Order may be cited as "The City of Edinburgh Council (Greenways) Order 1997";
- (2) This Order, with the exception of Articles 4, 5, 13, 19, 20, 22 and 23 and Schedules 1, 3, 4 and 5 shall come into operation on the Fourth day of August Nineteen hundred and Ninety seven;
- (3) Articles 4, 5, 13, 19 and 20 to the extent only that they apply to lengths of road or roads and turns specified or described in Schedules 2 and 6 shall come into operation on the Fourth day of August Nineteen hundred and Ninety seven;
- (4) Articles 4, 5, 13, 19 and 20 to the extent that they apply to lengths of road or roads and turns specified or described in Schedules 1, 3, 4 and 5 and Articles 22 and 23 shall come into operation on the First day of July Nineteen hundred and Ninety eight or whenever the relevant traffic signs are in place whichever shall be the later.

INTERPRETATION

- 2 (1) In this Order unless the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-
 - " bus lane" has the meaning given in regulation 23 (3) of the Traffic Signs Regulations 1994;
 - " bus stop" means an area of the carriageway of a road delineated by any of the markings specified in Diagrams 1025, 1025.1, 1025.2 and 1025.3 of Schedule 6 to the Traffic Signs Regulations 1994;
 - " buses" as used in Part VI of the Schedules means public service vehicles;
 - " carriageway" has the meaning given in section 151(2) of the Roads (Scotland) Act 1984;
 - " Chief Constable" means the Chief Constable for the Lothian and Borders police area;
 - " Council" means the City of Edinburgh Council incorporated under the Local Government Etc. (Scotland) Act 1994 as local authority for the City of Edinburgh area;
