THE CITY OF EDINBURGH COUNCIL (KAIMES JUNCTION) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/54

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Kaimes Junction) (Temporary Road Restriction and Traffic Regulation) Order 2024”. The order shall have effect on the Fourteenth day of May Two thousand and twenty-four and shall remain in force up to and including the Twenty-sixth day of July Two thousand and twenty-four.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4 of this Order, to facilitate carriageway resurfacing and drainage improvement works (as signed as affected by the works), no person shall, except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on **both sides** of (i) **Captain’s Road**, from the extended north-eastern kerbline of Howden Hall Road, north-eastwards to its junction with Southhouse Road; (ii) **Howden Hall Road**, from the extended north-western kerbline of Frogston Road East, north-westwards to its junction with Balmwell Terrace; (iii) **Frogston Road East**, from the extended south-western kerbline of Howden Hall Road, south-westwards to its junction with Greenwell Wynd; (iv) **Burdiehouse Road**, from the extended south-eastern kerbline of Captain’s Road, south-eastwards to the extended northern kerbline of its north junction with Janefield; (v) **Southhouse Road**, from its junction with Captain’s Road, south-eastwards for a distance of 20 metres or thereby; and (vi) **Gracemount Road**, from its junction with Howden Hall Road, north-eastwards for a distance of 20 metres or thereby.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3 of this Order.
