THE CITY OF EDINBURGH COUNCIL (EDINBURGH MARATHON FESTIVAL) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/63

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other enabling powers being satisfied that traffic on the lengths of roads specified in the Schedules hereto should be prohibited or restricted to facilitate the holding of the Edinburgh Marathon Festival event/s and to enable members of the public to watch this event and being satisfied that it is not reasonably practicable for the event to be held otherwise than on a road and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, with the consent of the Scottish Ministers under section 16B(1)(b) of the said Act, hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Edinburgh Marathon Festival) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect during the hours and on the dates specified in the Schedules to this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "event buses" means a vehicle authorised by City of Edinburgh Council as being connected with the event:
  - "liveried vehicle" means a vehicle displaying in permanent lettering and numbering the trading name and contact address or telephone number or e-mail address of the qualifying retailer or qualifying tradesperson to whom a permit has been issued;
  - "motor vehicle" has the same meaning as in Section 136 of the 1984 Act;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
  - "public service vehicle" has the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981, and, for the purposes of this Order, applies where the said vehicle or vehicles are being operated as a Local Service, as defined in the said Act;
  - "Schedule" means a Schedule to this Order;
  - "SFRS vehicles" means a liveried vehicle being used by the Scottish Fire & Rescue Service; "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate the holding of the Edinburgh Marathon Festival (as signed as affected by the event/s), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on the sections of roads specified in Schedule 1 hereto, where closures will apply to roads in their entirety unless otherwise stated;
  - (b) cause or permit any motor vehicle to enter, proceed or wait in or on any part of the lengths of roads specified in Schedule 2 hereto;
  - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads specified in Schedule 3 hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated; and

(d) drive or cause or permit any vehicle to be driven on the sections of roads specified in Schedule 4 hereto, otherwise than in the direction specified in the said Schedule.

### 4. Nothing in:

- (i) Article 3 shall apply to emergency service vehicles;
- (ii) Article 3(b) shall apply to *event buses* and *SFRS vehicles* on the respective sections of **Buccleuch Place** and **Restalrig Road South** described in Schedule 2; and
- (iii) Article 3(d) shall apply to *public service vehicles* for *Lothian Bus service No. 42* on the section of **Duddingston Road West** described in Schedule 4.
- 5. The 2018 Order shall be suspended in so far as it is affected by the restrictions specified in Schedule 3 of this Order.
- 6. 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading and Parking Places) (Variation No 1) Order 2010' shall be suspended between 05:00 hours and 11:00 hours on 26/05/2024 in relation to the one-way restriction on West Crosscauseway, to facilitate two-way traffic.
- 7. 'The Edinburgh Corporation (Nicolson Square) (One-Way) Order 1962' shall be suspended between 17:00 hours on 25/05/2024 and 13:00 hours on 26/05/2024 in relation to the one-way restriction on Nicolson Square, to facilitate two-way traffic on its south leg.
- 8. 'The City of Edinburgh Council (High Street, Edinburgh) (Prohibition of Motor Vehicles) (Variation No 1) Order 2011' shall be suspended between *06:00 hours and 12:00 hours on 26/05/2024* in relation to the *prohibition of motor vehicles* on the section of **High Street** between Parliament Square and Cockburn Street, to facilitate traffic use on the section of road.
- 9. 'The City of Edinburgh Council (Ramsay Lane and Castlehill, Edinburgh) (Prohibition of Entry) Traffic Regulation Order 1999' shall be suspended between *06:00 hours and 12:00 hours on 26/05/2024* in relation to the *prohibition of entry* on Ramsay Lane, to facilitate traffic access/egress from Ramsay Lane to Castlehill.
- 10. 'The City of Edinburgh Council (Johnston Terrace, Edinburgh) (Bus Priority Lane and One-Way) Traffic Regulation Order 2001' shall be suspended between 06:00 hours and 12:00 hours on 26/05/2024 in relation to the eastbound bus, taxi and cycle lane on Johnston Terrace, to permit general traffic to travel eastbound.
- 11. 'The Lothian Regional Council (Victoria Street, West Bow and Candlemaker Row, Edinburgh) Traffic Regulation Order 1995' shall be suspended between 06:00 hours and 12:00 hours on 26/05/2024 in relation to the one-way restrictions on Victoria Street and Candlemaker Row, to facilitate two-way traffic.
- 12. 'The Edinburgh Corporation (Meadowbank Avenue and Assembly Street) (One-Way) Order 1965' shall be suspended between *06:00 hours and 12:30 hours on 26/05/2024* in relation to the *one-way restriction* on **Meadowbank Avenue**, to facilitate two-way traffic.

13. The alternative routes for through vehicular traffic will be by way of Melville Drive, Brougham Place, Brougham Street, Earl Grey Street and Lothian Road; or South Bridge, North Bridge and Waterloo Place.

**London Road**, *both sides*, between its junction with Meadowbank Terrace and its junction with Willowbrae Road:

- (i) Potterrow; (ii) Chapel Street; (iii) Buccleuch Street; (iv) Buccleuch Place: (1) north side, in its entirety; and (2) south side, from the projected east property boundary of No. 21 Buccleuch Place, westwards for a distance of 40 metres or thereby (including central reservation parking); (v) Marshall Street; (vi) Nicolson Square, all sides in its entirety; (viii) George Square, all sides in its entirety; (viii) George Square Lane; (ix) Crichton Street; (x) Charles Street; (xi) West Crosscauseway; (xii) Meadow Lane; (xiii) Forrest Road; (xiv) Teviot Place; (xv) Hope Park Crescent; (xvi) Bristo Place; (xvii) George IV Bridge; (xviii) Bank Street; (xix) North Bank Street; (xx) The Mound; (xxi) South Bridge; (xxii) Waverley Bridge; (xxiii) Market Street; and (xxiv) Jeffrey Street; and
- (G) from 18:30 hours on 23/05/2024 to 22:00 hours on 27/05/2024 on:

George Square, *south side*, north-east corner section between east-west leg and north-south cul-desac section (8 P&D and 1 solo M/CS bay).

### SCHEDULE 4 ONE-WAY ROADS

(A) from 06:00 hours to 11:00 hours on 25/05/2024 on:

**Duddingston Road West**, between its junction with The Causeway and its junction with North Cairntow, otherwise than in a *southbound* direction (*except Lothian Bus service No. 42*); and

(B) <u>from 06:00 hours to 11:00 hours on 26/05/2024</u> on:

**Hanover Street**, between its junction with Princes Street and its junction with Rose Street, otherwise than in a *northbound* direction.
