## **Executive Summary**

This report describes the conformance of the City of Edinburgh's website with W3C's Web Content Accessibility Guidelines (WCAG) (https://www.w3.org/WAI/standards-guidelines/wcag/).

The review process is described in Audit Process Introduction section below and is based on evaluation described in Accessibility Evaluation Resources (https://www.w3.org/WAI/eval/).

Based on this evaluation, the City of Edinburgh's website is close to meeting WCAG 2.1, WCAG 2.2, Conformance Level AA.

Detailed review results are available in the Audit Results Summary and Recommended Actions section below.

Feedback on this evaluation is welcome.

# **Evaluation Background**

The City of Edinburgh Council website (www.edinburgh.gov.uk) offers core council services as well as a resource for citizens and visitors to the City of Edinburgh to access news, performance, and research information.

The City of Edinburgh Council recognise the importance of providing user-centred and inclusive services to all users, this includes users with disabilities in addition to those that do not require additional needs.

It is important to the City of Edinburgh Council to have a clear understanding of any accessibility issues for users of their services.

#### **Client Goals**

- #1: Provide a clear understanding of any accessibility issues for users of their services.
- **#2**: Determine whether there are any accessibility barriers remaining on the Council website.
- **#3:** Microsoft Windows devices, Android, Apple (iPhone/iPad) devices and a wide range of browsers to be included to ensure the website can be used by the widest audience in the client user base.
- **#4:** Ensure compliance with WCAG 2.2 A/AA and the Public Sector Bodies (Websites and Mobile Applications) (No.2) Accessibility Regulations 2018.
- **#5:** Assessment methodology consistent with WCAG recommended guidelines.
- **#6:** Assessment reporting including scope of the assessment, methodology, summary of findings, and any recommendations, where applicable, on how the findings can be addressed.

#### **Primary Objectives**

- **To conduct a thorough audit** of the City of Edinburgh Council's website against the Public Accessibility Regulations 2018 and WCAG 2.2 standards.
- To identify any accessibility barriers within the website and recommend actionable improvements.

• To ensure that the website offers an inclusive user experience, meeting the needs of all users, including those with disabilities.

# **Audit Process Introduction**

The website samples listed in Appendix I were measured against the Web Accessibility Initiative's (WAI) Web Content Accessibility Guidelines 2.2 (WCAG 2.2) Level A And AA, to give accurate feedback on non-compliance issues.

Successful compliance and accreditation are defined by meeting and achieving success in all WCAG (A) and (AA) criteria markers.

The ATC Audit team uses three different testing methods to accurately measure the website samples' compliance.

#### Methodology

We assessed both the template accessibility and content accessibility of the agreed sample set using the following:

- 1. A selection of webpages that incorporate diverse components and designs implemented on the website, including various navigational elements, content elements, or types of content.
- 2. The user journeys to be navigated by users throughout the site.
- 3. The different types of browsers and assistive technology to be tested.

#### Automatic Testing

Each sample was tested with a bespoke automated testing platform that utilises gold standard industry standard tools (PA11Y, AXE-Core, Wave). Results were verified by manual review of criteria failures where appropriate to reduce false positives, i.e. colour contrast based on font size.

#### Manual Testing

Testing WCAG 2.2 AA principles manually based on a feature set of sample pages, i.e. ensuring tables, lists, images, etc., are detectable and usable programmatically.

This stage was performed using the appropriate assistive technology and across multiple browsers as identified in the scope.

Where appropriate, code review was conducted of sample pages to ensure proper WCAG 2.2 AA criteria compliance.



The Google Analytics account for (www.edinburgh.gov.uk) helped us to analyse actual user engagement and behaviour directly. This enabled us to identify the most frequently used features and user journeys, ensuring that the usability audit priorities focused on areas of high user impact, balanced with <u>test data available</u>.

This enabled us to determine a meaningful user journey testing set shown below.

#### **User Journey Testing Set**



- Motor / Neuromuscular alternative input methods including speech recognition and voice access.




Table 6 - User Journey Difficulty

#### **Recommended Actions**

#### Summary review interpretation

The collection of websites tested (the agreed sample) is close to meeting WCAG2.1 A, AA in many of the standardised templates with some modifications required to the design elements of others.

For the most part many of the deficiencies identified occurred with older or non-standard templates or interface/interaction with other partner websites.

Areas of strength were the use of keyboard access, landmarks and regions and appropriate headings and suitable link structure.

Recommended priorities for addressing inaccessible features are focused on the header and navigation bar areas and widgets such as Cookies and Chatbot interaction. To a lesser degree some minor modification and remediation is required to several elements of form field data processing.

#### **Detailed Audit results**

Since the audit was performed for all 56 WCAG criteria over effectively **28-30** different template types including Forms and branches amounted to **42** web pages tested which is a significant volume.
