THE CITY OF EDINBURGH COUNCIL (EDINBURGH INTERNATIONAL CHILDREN'S FESTIVAL) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/60

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 62 of the Roads (Scotland) Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- This Order may be cited as "The City of Edinburgh Council (Edinburgh International Children's Festival) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect during the hours and on the dates specified in the Schedule to this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the Road Traffic Regulation Act 1984;
  - "Schedule" means a Schedule to this Order;
  - "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate the safe access/egress of children at Festival venues (as signed as affected by the event/s), no person shall, except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads described in the Schedule hereto.
- 4. Nothing in Article 3 of this Order shall apply to emergency service vehicles.
- 5. The 2018 Order shall be suspended on the affected sections of roads described in the Schedule.

## SCHEDULE PROHIBITION OF WAITING, LOADING & UNLOADING

(A) <u>from 08:00 hours to 17:00 hours DAILY from 27/05/2024 to 01/06/2024</u> on:

**Castle Terrace**, *south side*, from its junction with Cambridge Street, south-eastwards for a distance of 50 metres or thereby;

(B) <u>from 08:00 hours to 17:00 hours DAILY from 27/05/2024 to 02/06/2024</u> on:

**Roxburgh Place**, *east side*, from its junction with Drummond Street, south-eastwards for a distance of 30 metres or thereby;

(C) from 08:30 hours to 17:00 hours DAILY from 27/05/2024 to 30/05/2024 on:

**Hope Park Terrace**, *south side*, from a point 10 metres or thereby south-west of the extended western kerbline of South Clerk Street, south-westwards for a distance of 48 metres or thereby;

(D) from 08:30 hours to 17:00 hours DAILY from 29/05/2024 to 31/05/2024 on:

**King's Stables Road**, *north side*, from a point 7.5 metres or thereby west of the western edge of the wall adjacent Granny's Green Steps, westwards for a distance of 50 metres or thereby; and

(E) <u>from 08:30 hours to 17:00 hours DAILY from 28/05/2024 to 30/05/2024</u> on:

**High Street**, *north side*, from a point 90 metres or thereby west of the extended western kerbline of Jeffrey Street, westwards for a distance of 30 metres or thereby.
