THE CITY OF EDINBURGH COUNCIL (WEST APPROACH ROAD) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/82

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (West Approach Road) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect on the Twenty-seventh day of May Two thousand and twenty-four and shall remain in force up to and including the Twenty-seventh day of July Two thousand and twenty-four.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order; "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes; and "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate bridge structural repair works (as signed as affected by the works), no person shall, drive or cause or permit to be driven any vehicle on West Approach Road: (1) 7am to 5pm; and 7pm to 7am DAILY: (i) from the extended eastern kerbline of Roseburn Street, generally eastwards to the point where the western section of the West Approach Road meets the on-ramp from Dundee Street; (ii) from the westbound exit on the eastern section of the West Approach Road, northwards to the point it meets the eastbound on-slip from the western section; (iii) from the exit from the eastern section of the West Approach Road, south-westwards to its junction with Angle Park Terrace/Dundee Street; and (2) 7pm to 7am DAILY only, at its junction with Dundee Street (at eastbound on-ramp), provided that no more than one of the measures described in this section shall be enacted at any time.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The alternative routes for through vehicular traffic with respect to the *closures* will be by way of: (1) Westfield Road, Stevenson Road, Balgreen Road, Gorgie Road, Henderson Terrace and Dundee Street; (2) West Approach Road (*westbound*), Henderson Terrace, Gorgie Road, Balgreen Road, Stevenson Road and Westfield Road; (3) West Approach Road (*westbound*) (towards western section), Westfield Road, Stevenson Road and Balgreen Road; and (4) Dundee Street, Fountainbridge, Semple Street, Morrison Street and Morrison Link.
