THE CITY OF EDINBURGH COUNCIL (ALBION TERRACE & BOTHWELL STREET AREA)
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 –
TEMP/24/93

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Sections 14 (1) (a) and (b) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Albion Terrace & Bothwell Street Area) (Temporary Road Restriction and Traffic Regulation) Order 2024”. The order shall have effect on the Thirty-first day of May Two thousand and twenty-four and shall remain in force up to and including the Twenty-eighth day of July Two thousand and twenty-four.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restriction on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4 of this Order, to facilitate a safe working area for painting and structural repair works on Crawford Bridge (as signed as affected by the works), no person shall:-
 - (a) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on **both sides** of: (i) **Albion Terrace**, from the projected west building line of No. 3 Albion Terrace, south-westwards to the south-westernmost extent of the cul-de-sac (*where the carriageway meets the footway leading to Crawford Bridge*); and (ii) **Bothwell Street**, from the projected west building line of No. 15 Bothwell Street, north-eastwards to the north-easternmost extent of the cul-de-sac (*where the carriageway meets the footpath of Crawford Bridge*); and
 - (b) walk or cause or permit any person to walk on the **Crawford Bridge** footpath, in its entirety.
4. Nothing in Article 3(a) shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2018 Order will be suspended in so far as it is affected by restrictions specified in Article 3(a) of this Order.
6. Pedestrian access will be maintained on **Albion Terrace** and **Bothwell Street**.
