THE CITY OF EDINBURGH COUNCIL (BEAUFORT ROAD, CUMIN PLACE, GRANGE ROAD, LAUDER ROAD AND TANTALLON PLACE, EDINBURGH) (REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE) ORDER 2024 - RSO/18/17A

The City of Edinburgh Council, in exercise of the power conferred on them by sections 1(1) and 152(2) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, hereby make the following Order:-

- 1. This Order may be cited as "The City of Edinburgh Council (Beaufort Road, Cumin Place, Grange Road, Lauder Road and Tantallon Place, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 2024" and shall come into operation on the Third day of June Two thousand and Twenty-four.
- 2. The roads in the City of Edinburgh local government area specified in the First Schedule to this Order, at present footway, shall become cycle track, the right of passage being exercisable by pedal cycle and foot only.
- 3. The roads in the City of Edinburgh local government area specified in the Second Schedule to this Order, at present carriageway, shall become cycle track, the right of passage being exercisable by pedal cycle and foot only.
- 4. The roads in the City of Edinburgh local government area specified in the Third Schedule to this Order, at present carriageway, shall become footway, the right of passage being exercisable on foot only.
- 5. The roads in the City of Edinburgh local government area specified in the Forth Schedule to this Order, at present footway, shall become carriageway, the right of passage being exercisable by all classes of traffic.

SCHEDULE 1

ROADS OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM FOOTWAY TO CYCLETRACK

Cumin Place

West side

1. All that part of the footway on the west side of Cumin Place from a point 2 metres or thereby south of the intersection of the extended south kerbline of Grange Road and the extended west kerbline of Cumin Place, southwards for a distance of 8 metres or thereby and which has a width throughout of 1.5 metres or thereby.

Grange Road

North side

1. All that part of the footway on the north side of Grange Road from the intersection of the extended east kerbline of Lauder Road and the extended north kerbline of Grange Road, eastwards for a distance of 6 metres or thereby and which has a width which varies from 0 metres or thereby to 2.5 metres or thereby.

2. All that part of the footway on the north side of Grange Road from the intersection of the extended west kerbline of Tantallon Place and the extended north kerbline of Grange Road, westwards for a distance of 4.5 metres or thereby and which has a width which varies from 0 metres or thereby to 2.5 metres or thereby.

South side

- 1. All that part of the footway on the south side of Grange Road and the east side of Lauder Road from a point 7 metres or thereby east of the intersection of the extended east kerbline of Lauder Road and the extended south kerbline of Grange Road, westwards and then southwards into Lauder Road, to a point 9 metres or thereby south of said intersection above and which has a width throughout of 2 metres or thereby. (marked 15 on the attached Plan).
- 2. All that part of the footway on the south side of Grange Road from the intersection of the extended west kerbline of Cumin Place and the extended south kerbline of Grange Road, westwards;
 - a). for a distance of 2.5 metres or thereby and which has a width which varies from 0 metres or thereby to 2 metres or thereby and then,

Lauder Road

East side

- 1. All that part of the footway on the east side of Lauder Road from a point 2.5 metres or thereby north of the intersection of the extended north kerbline of Grange Road and the extended east kerbline of Lauder Road, northwards;
 - a). for a distance of 2 metres or thereby and which has a width which varies from 4 metres or thereby to 2 metres or thereby and then,
 - b). for a distance of 5.5 metres and which has a width throughout of 2 metres or thereby.

2. See Grange Road, South side 1. (marked 15 on the attached plan).

Tantallon Place

West side

- All that part of the footway on the west side of Tantallon Place from a point 2.5 metres or thereby north of the intersection of the extended north kerbline of Grange Road and the extended west kerbline of Tantallon Place, northwards;
 - a). for a distance of 1 metre or thereby and which has a width which varies from 2 metres or thereby to 1.5 metres or thereby and then,
 - b). for a distance of 7 metres and which has a width throughout of 1.5 metres or thereby.

 - b). for a distance of 8 metres or thereby and which has a width throughout of 1 metre or thereby.

- All that part of the carriageway on the east side of Lauder Road from a point

 - b). for a distance of 7.5 metres or thereby and which has a width throughout of 6 metres or thereby then,
 - c). for a distance of 7 metres or thereby and which has a width throughout of 3.5 metres or thereby and then,
 - d). for a distance of 3 metres or thereby and which has a width that varies from 3 metres or thereby to 0 metres or thereby.

Tantallon Place

 - a). for a distance of 2.5 metres or thereby and which has a width that varies from 4 metres or thereby to 3 metres or thereby then,
 - b). for a distance of 4.5 metres or thereby and which has a width throughout of 3 metres or thereby then,
 - c). for a distance of 2 metres or thereby and which has a width that varies from 3 metres or thereby to 1.5 metres or thereby and then,
 - d). for a distance of 1 metre or thereby and which has a width throughout of 1.5 metres or thereby.

 - b). for a distance of 1 metre or thereby and which has a width that varies from 1 metres or thereby to throughout of 0 metres or thereby. (marked 14 on the attached Plan).

Lauder Road

East side

- 1. All that part of the carriageway on the east side of Lauder Road from a point 10 metres or thereby north of the intersection of the extended north kerbline of Grange Road and the extended east kerbline of Lauder Road, northwards for a distance of 10 metres or thereby and which has a width throughout of 2 metres or thereby.
 - (marked 3 on the attached Plan).
- 2. All that part of the carriageway on the east side of Lauder Road from a point 9 metres or thereby south of the intersection of the extended south kerbline of Grange Road and the extended east kerbline of Lauder Road, southwards for a distance of 12 metres or thereby and which has a width throughout of 1.5 metres or thereby.

West side

- 1. All that part of the carriageway on the west side of Lauder Road from a point 2 metres or thereby west of the intersection of the extended north kerbline of Grange Road and the extended west kerbline of Lauder Road, northwards;
 - a). for a distance of 3 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby then,
 - b). for a distance of 6 metres or thereby and which has a width throughout of 2 metres or thereby and then,

- c). for a distance of 2 metres or thereby and which has a width that varies from 2 metres or thereby to 0 metres or thereby. (marked 1 on the attached Plan).
- 2. All that part of the carriageway on the west side of Lauder Road from a point 1 metre or thereby south of the intersection of the extended south kerbline of Grange Road and the extended west kerbline of Lauder Road, southwards for a distance of 21 metres or thereby and which has a width that varies from 0 metre or thereby to 0.5 metres or thereby and then to 0 metres or thereby. (marked 18 on the attached Plan).

ROADS OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM FOOTWAY TO CARRIAGEWAY

Grange Road

All that part of the footway on the south side of Lauder Road from a point 1 metre or thereby west of the intersection of the extended west kerbline of Lauder Road and the extended west kerbline of Lauder Road, eastwards and then southwards to a point in Lauder Road 1 metre or thereby south of the said intersection above and which has a width that varies from 0 metres or thereby to 0.25 metres or thereby and then to 0 metres or thereby.
