THE CITY OF EDINBURGH COUNCIL (ROYAL HIGHLAND SHOW) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/94

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Royal Highland Show) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect during the hours and on the dates specified in Schedules 1 to 6 and Articles 7 and 8 of this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;

"authorised event vehicle" means any vehicle authorised by City of Edinburgh Council as being connected with the event;

"emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;

"event specific bus" means a local service bus being used for the sole purpose of transporting people to/from the Royal Highland Show;

"local buses" means a public service vehicle used for the provision of a local service not being an excursion or tour;

"motor vehicle" has the same meaning as in Section 136 of the 1984 Act;

"Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;

"public service vehicle" has the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981, and, for the purposes of this Order, applies where the said vehicle or vehicles are being operated as a Local Service, as defined in the said Act; "Schedule" means a Schedule to this Order;

"the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and

"vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.

- 3. Save as provided in Articles 4 and 5, to facilitate the free flow of traffic during the Royal Highland Show (as signed as affected by the event), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on the section of road specified in Schedule 1 hereto;
 - (b) drive or cause or permit to be driven any motor vehicle on the section of road specified in Schedule 2 hereto;
 - (c) drive or cause or permit to be driven any motor vehicle on the sections of roads described in Schedule 3 hereto, otherwise than in the direction specified in the said Schedule; and
 - (d) except with the permission of a Parking Attendant, cause or permit any vehicle to wait, or load onto or unload from any vehicle on the sections of roads specified in Schedule 4 hereto.
- 4. Nothing in:
 - (i) Schedules 1-6 shall apply to emergency service vehicles;
 - Schedules 2 and 3 shall apply to *authorised event vehicles* on the sections of Almond
 Drive, Fairview Road and Hallyards Road specified in the said Schedules; and
 - (iii) Schedules 3 and 4 shall apply to *event specific buses* on the sections of **George Street** and **Ingliston Road** specified in the said Schedules.

- 5. Nothing in Schedule 3 (One-way roads) and Schedule 5 (**Lochend Road**, prohibited right turn) of this Order, shall prevent any vehicle access/egress to premises/properties on Hallyards Road only by prior arrangement between the affected parties and the Royal Highland Show organisers.
- 6. Save as provided in Article 3, no person shall, except with the permission of the most senior Police Scotland officer in attendance, drive or cause or permit to be driven any vehicle on the road specified in column 1 so as to make the prohibited turn specified in column 2, into the road specified in column 3 of Schedule 5.
- 7. No person shall, drive or cause or permit to be driven any vehicle on the roads specified in column 1 so as to drive at a speed in excess of that specified in column 2, which shall reduce the speed limit from that specified in column 3, during the hours and on the dates specified in Schedule 6 to this Order.
- 8. No person shall, drive or cause or permit to be driven any vehicle so as to perform a U-turn manoeuvre on **Glasgow Road** (A8) (*both directions*), between Newbridge roundabout and Gogar roundabout, from 07:00 hours on 17/06/2024 to 23:00 hours on 24/06/2024, as signed as affected by the event.
- 9. The 2018 Order shall be suspended in so far as it is affected by the restrictions specified in Schedule 4 to this Order.
- 10. 'The City of Edinburgh Council (Eastfield Road, Edinburgh) (40 mph Speed Limit) Order 2009' will be suspended during the hours specified in Schedule 6 hereto, to facilitate the introduction of the temporary speed limit specified in the said Schedule.
- 11. The alternative routes of travel for vehicular traffic with respect to the restrictions imposed by this Order will be by way of Glasgow Road (A8), Eastfield Road and Fairview Road.

SCHEDULE 1 ROAD CLOSURE

From 23:59 *hours on* 19/06/2024, 20/06/2024, 21/06/2024 and 22/06/2024 to 02:30 hours on 20/06/2024, 21/06/2024, 22/06/2024 and 23/06/2024 respectively on: **Ingliston Road**, between its junction with Glasgow Road (A8) and its junction with Fairview Road.

SCHEDULE 2 PROHIBITION OF MOTOR VEHICLES

From 21:00 hours on 19/06/2024, 20/06/2024, 21/06/2024 and 22/06/2024 to 02:30 hours on 20/06/2024, 21/06/2024, 22/06/2024 and 23/06/2024 respectively on: **Fairview Road**, between its junction with Ingliston Road and its junction with Almond Drive (*except authorised event vehicles*).

SCHEDULE 3 ONE-WAY ROADS

(A) from 07:00 hours to 21:00 hours on 20/06/2024, 21/06/2024, 22/06/2024 and 23/06/2024 on: **Eastfield Road/Ingliston Interchange**, from the extended south-western kerbline of the eastbound on-slip to Glasgow Road (A8) (*north roundabout*), southwards to the extended north-western kerbline of the westbound off-slip from Glasgow Road (A8) (*south roundabout*), otherwise than in a *northbound* direction;

(B) from 07:00 hours on 15/06/2024 to 23:59 hours on 19/06/2024 on: **Ingliston Road**, from its junction with Glasgow Road (A8) to the entrance to Little Flyers Nursery, otherwise than in a *southbound* direction;

(C) *from 23:59 hours on 19/06/2024 to 23:59 hours on 23/06/2024* on: **Ingliston Road**, from its junction with Glasgow Road (A8) to the north entrance to the BCA Car Park (end of fence line), otherwise than in a *southbound* direction (*except event specific buses*);

(D) from 23:59 hours on 23/06/2024 to 17:00 hours on 24/06/2024 on: **Ingliston Road**, from its junction with Glasgow Road (A8) to the north entrance to the BCA Car Park (*end of fence line*), otherwise than in a *southbound* direction;

(E) from 21:00 hours on 19/06/2024, 20/06/2024, 21/06/2024 and 22/06/2024 to 02:30 hours on 20/06/2024, 21/06/2024, 22/06/2024 and 23/06/2024 respectively on:

(i) **Fairview Road**, between its junction with Eastfield Road and its junction with Almond Drive, otherwise than in an *eastbound* direction; and (ii) **Almond Drive**, between its junction with Fairview Road and its junction with Almond Avenue, otherwise than in a *southbound* direction (*except authorised event vehicles*);

(F) from 00:01 hours to 12:59 hours on 20/06/2024, 21/06/2024, 22/06/2024 and 23/06/2024 on: **Lochend Road**, between its junction with Hallyards Road and its junction with the B800, otherwise than in a *southbound* direction (*except for prearranged access for residents/businesses in Hallyards Road*);

(G) from 13:00 hours to 23:59 hours on 20/06/2024, 21/06/2024, 22/06/2024 and 23/06/2024 on: **Lochend Road**, between its junction with Hallyards Road and its junction with the B800, otherwise than in a *northbound* direction (*except for prearranged access for residents/businesses in Hallyards Road*);

(H) from 07:00 hours on 20/06/2024 to 23:59 hours on 23/06/2024 on: Hallyards Road, from its junction with Glasgow Road (A8) to the entrance of Ingliston Showground (West Gate - 13), otherwise than in a *southbound* direction (*except for local residents' and businesses' vehicles and authorised event vehicles*); and

(I) from 23:59 hours on 23/06/2024 to 17:00 hours on 26/06/2024 on: Hallyards Road, from its junction with Glasgow Road (A8) to the entrance of Ingliston Showground (West Gate - 13), otherwise than in a *southbound* direction (*except for local residents' and businesses' vehicles*).

SCHEDULE 4 PROHIBITION OF WAITING, LOADING AND UNLOADING

(A) from 19:00 hours on 19/06/2024, 20/06/2024, 21/06/2024 and 22/06/2024 to 03:30 hours on 20/06/2024, 21/06/2024, 22/06/2024 and 23/06/2024 respectively on:

(i) **Almond Drive**, *both sides*, between its junction with Fairview Road and its junction with Almond Avenue; and (ii) **Fairview Road**, *both sides*, in its entirety;

(B) from 06:00 hours on 20/06/2024 to 23:59 hours on 23/06/2024 on:

George Street, *both sides*, between its junction with Hanover Street and its junction with Frederick Street (*excluding central reserve bays*) (*except event specific buses*);

(C) from 07:00 hours on 20/06/2024 to 23:59 hours on 23/06/2024 on:

Hallyards Road, *both sides*, from its junction with Glasgow Road (A8) to the entrance to the Ingliston Showground (West Gate – 13);

(D) from 07:00 hours to 16:29 hours on 20/06/2024; from 02:31 hours to 16:29 hours on 21/06/2024; from 02:31 hours to 16:29 hours on 22/06/2024; and from 02:31 hours to 23:59 hours on 23/06/2024 on:

Glasgow Road (*A*8): (i) for the length of the bus stop (*approximately 10 metres or thereby*) in the layby (*north side*) outside Nos. 95-97 Glasgow Road (A8); (ii) for the length of the lay-by (*north side*) between lamp column GFC 349 and lamp column GFC 350 (*The location is just east of Ratho Station*); and (iii) for the length of the lay-by (*south side*) between lamp column GFC 282 and lamp column GFC 283 (*The location is east of Ratho Station*); and

(E) from 16:30 hours on 20/06/2024, 21/06/2024 and 22/06/2024 to 02:30 hours on 21/06/2024, 22/06/2024 and 23/06/2024 respectively on:

Glasgow Road (*A8*) *full length*: (a) *north side*, from Newbridge Roundabout, eastwards to the Eastfield Road eastbound off-slip (*except residents' parking between Nos. 67-75 & 95-123 Glasgow Road*); and (b) *south side*, from the top of the westbound Eastfield Road on-slip, westwards to Newbridge Roundabout.
