THE CITY OF EDINBURGH COUNCIL (ROXBURGH PLACE) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/100

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other enabling powers being satisfied that traffic on the lengths of roads specified in Article 3 should be prohibited or restricted to facilitate the holding of festival events on Roxburgh Place, and to enable members of the public to watch this event and being satisfied that it is not reasonably practicable for the event to be held otherwise than on a road and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, with the consent of the Scottish Ministers under section 16B(1)(b) of the said Act, hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Roxburgh Place) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect during the hours and on the dates specified in Article 3 of this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
 "Schedule" means a Schedule to this Order;
 "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and

"vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.

- 3. Save as provided in Article 4, to facilitate the holding of festival events on Roxburgh Place (as signed as affected by the event), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle *between 00:01 hours on 17/07/2024* and 23:59 hours on 29/08/2024 on Roxburgh Place, from its junction with Drummond Street, south-eastwards for a distance of 45 metres or thereby; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle *between 21:00 hours on 17/07/2024 and 23:59 hours on 29/08/2024* on *both sides* of Roxburgh Place, from its junction with Drummond Street, south-eastwards for a distance of 45 metres or thereby.
- 4. Nothing in Article 3 of this Order shall apply to emergency service vehicles.
- 5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

6. The alternative route for through vehicular traffic will be by way of Roxburgh Street and West Adam Street.
