THE CITY OF EDINBURGH COUNCIL (HILL SQUARE FRINGE FESTIVAL) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/113

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -


1. This Order may be cited as “The City of Edinburgh Council (Hill Square Fringe Festival) (Temporary Road Restriction and Traffic Regulation) Order 2024”. The order shall have effect during the hours and on the dates specified in Article 3 of this Order.
2. In this Order the following phrases have the meanings respectively assigned to them:
 - “Article” means an Article of this Order;
 - “emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
 - “event vehicle” means any vehicle authorised by the City of Edinburgh Council as being connected with the event;
 - “motor vehicle” has the same meaning as in Section 136 of the 1984 Act;
 - “Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
 - “the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
 - “vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate a safe area for attendees to the Hill Square Fringe Festival (as signed as affected by the event), no person shall **between 10:00 hours on 15/07/2024 and 08:00 hours on 01/09/2024:-**
 - (a) drive or cause or permit to be driven any vehicle on **Hill Square**, in its entirety;
 - (b) drive or cause or permit to be driven any motor vehicle on **Hill Place**, between its westmost junction with Hill Square and its junction with Richmond Place, otherwise than in an **eastbound** direction; and
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on **Hill Square, both sides**, in its entirety.
4. Nothing in:
 - (i) Article 3(a) shall apply to event vehicles; and
 - (ii) Article 3 shall apply to emergency service vehicles.
5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(c) of this Order.
6. The alternative route for through vehicular traffic with respect to the **one-way restriction** will be by way of Richmond Place, West Richmond Place and Nicolson Street.

7. There is no available diversion with respect to the *prohibition of vehicles* on **Hill Square**.
