THE CITY OF EDINBURGH COUNCIL (STRATHEARN ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/118

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Strathearn Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect on the Fifteenth day of July Two thousand and twenty-four up to and including the Twenty-fifth day of October Two thousand and twenty-four.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate SGN mains renewal works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on **Greenhill Place**, at its junction with Strathearn Place;
  - (b) drive or cause or permit to be driven any vehicle on: (i) **Forbes Road**, between its junction with Bruntsfield Gardens and its junction with Chamberlain Road, *otherwise than in a southbound direction*; (ii) **Palmerston Road**, in its entirety, *otherwise than in a northbound direction*; and (iii) **Greenhill Park**, between its junction with Morningside Road and its junction with Chamberlain Road, *otherwise than in a south-westbound direction*; and
  - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on both sides of: (i) Greenhill Park, between its junction with Chamberlain Road and its junction with Morningside Road; (ii) Chamberlain Road, from its junction with Forbes Road, eastwards and westwards for a distance of 50 metres or thereby respectively; (iii) Forbes Road, between its junction with Chamberlain Road and its junction with Bruntsfield Gardens; (iv) Strathearn Place, in its entirety; (v) Strathearn Road, in its entirety; (vi) Strathfillan Road, from its junction with Strathearn Road, northwards for a distance of 35 metres or thereby; (vii) Beaufort Road, between its junction with Marchmont Road and its junction with Chalmers Crescent; (viii) Palmerston Road, from its junction with Beaufort Road, northwards for a distance of 30 metres or thereby; (ix) Greenhill Place, from its junction with Strathearn Place, northwards for a distance of 30 metres or thereby; (x) Kilgraston Road, from its junction with Strathearn Road, southwards for a distance of 55 metres or thereby; (xi) Whitehouse Loan, from its junction with Strathearn Place, northwards for a distance of 50 metres or thereby; and (xii) Marchmont Road, from its junction with Strathearn Road, northwards for a distance of 45 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.

- 5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(c) of this Order.
- 6. The alternative route for through vehicular traffic with respect to the *closure* on **Greenhill Place** will be by way of Greenhill Place, St Margaret's Road, Whitehouse Loan and Strathearn Place.
- The alternative routes for through vehicular traffic with respect to the *one-way restrictions* will be by way of: (i) Forbes Road Chamberlain Road, Bruntsfield Place and Forbes Road; (ii) Palmerston Road Chalmers Crescent and Beaufort Road; and (iii) Greenhill Park Morningside Road and Chamberlain Road.
