THE CITY OF EDINBURGH COUNCIL (EDINBURGH INTERNATIONAL BOOK FESTIVAL) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/104

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Edinburgh International Book Festival) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect during the hours and on the dates specified in the Schedule to this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate public safety at festival venues (as signed as affected by the event/s), no person shall, except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads specified in the Schedule hereto.
- 4. Nothing in Article 3 shall apply to emergency service vehicles.
- 5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3 of this Order.

SCHEDULE PROHIBITION OF WAITING, LOADING & UNLOADING

(A) from 07:00 hours on 24/07/2024 to 23:59 hours on 04/09/2024 on: **Nightingale Way** (north-south section), east side, from the southern kerbline of Nightingale Way (east-west section), northwards for a distance of 30 metres or thereby; and

- (B) from 07:00 hours on 24/07/2024 to 23:59 hours on 09/08/2024; and from 07:00 hours on 26/08/2024 to 23:59 hours on 04/09/2024 on:
- (i) **Nightingale Way** (*east-west section*): (a) *north side*: (i) from the extended western kerbline of Simpson Loan (*north-south section*), eastwards to the extended western kerbline of Archibald Place; and (ii) from the extended eastern kerbline of Archibald Place, eastwards for a distance of 30 metres or thereby; and (b) *south side*, from a point 25 metres or thereby east of the extended eastern kerbline of Archibald Place, eastwards to the eastern kerbline of Nightingale Way (*north-south section*); and (ii) **Simpson Loan**: (1) **north-south section** (*at its western end*), *both sides*, in its entirety; and (2) **east-west section**: (a) *north side*, from the westmost extremity of the disabled parking bays, eastwards for a distance of 30 metres or thereby; and (b) *south side*: (i) from the eastmost edge of the cul-de-sac, westwards for a distance of 70 metres or thereby; and (ii) from a point 25 metres or thereby east of the extended eastern kerbline of Chalmers Street, eastwards for a distance of 60 metres or thereby.
