THE CITY OF EDINBURGH COUNCIL (BALGREEN ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/135

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Balgreen Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect on the Twenty-fourth day of July Two thousand and twenty-four and shall remain in force up to and including the Thirteenth day of August Two thousand and twenty-four.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate a safe working area for ducting works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on: (i) **Baird Drive**, from the extended eastern kerbline of Balgreen Road, north-eastwards for a distance of 20 metres or thereby; and (ii) **Balgreen Road**, between its junction with Stevenson Drive and its junction with Saughtonhall Drive; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of: (i) **Balgreen Road**, from the extended north-western kerbline of Stevenson Road, north-westwards to its junction with Glendevon Road; and (ii) **Saughtonhall Drive**, from its junction with Balgreen Road, northwards to the projected south property boundary of Nos. 137/139 Saughtonhall Drive.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
- 6. The alternative routes for through vehicular traffic will be by way of: (i) **Baird Drive** Baird Grove, Saughtonhall Avenue and Saughtonhall Drive; and (ii) **Balgreen Road** Corstorphine Road, St John's Road, Meadow Place Road (B701), Calder Road (A71), Stenhouse Road and Gorgie Road.
