THE CITY OF EDINBURGH COUNCIL (LONG DALMAHOY ROAD AREA, BALERNO)
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 –
TEMP/24/88

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -


1. This Order may be cited as “The City of Edinburgh Council (Long Dalmahoy Road Area, Balerno) (Temporary Road Restriction and Traffic Regulation) Order 2024”. The order shall have effect on the Twenty-ninth day of July Two thousand and twenty-four and shall remain in force up to and including the Twenty-second day of September Two thousand and twenty-four.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate carriageway strengthening works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on: (i) **Gowanhill Farm Road**, at its junction with Long Dalmahoy Road; (ii) **Long Dalmahoy Road**, between its junction with Curriehill Road and its junction with Haggs Farm Road; (iii) **Ravelrig Road**, at its junction with Long Dalmahoy Road; and (iv) **Warriston Farm Road**, at the projected north-western boundary of Long Dalmahoy Road; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of: (i) **Curriehill Road**, from the projected centre line of Long Dalmahoy Road, north-westwards and south-eastwards for a distance of 50 metres or thereby respectively; (ii) **Haggs Farm Road**, from the projected centre line of Long Dalmahoy Road, generally northwards and southwards for a distance of 50 metres or thereby respectively; and (iii) **Long Dalmahoy Road**, between its junction with Curriehill Road and its junction with Haggs Farm Road.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The alternative routes for through vehicular traffic will be by way of: (i) **Gowanhill Farm Road** – access maintained from Newmills Road; (ii) **Long Dalmahoy Road** – Haggs Farm Road, A71 and Curriehill Road; (iii) **Ravelrig Road** – access maintained from Lanark Road West.

6. The following road has no available diversion: **Warriston Farm Road.**
