

ROADS (SCOTLAND) ACT 1984

THE CITY OF EDINBURGH COUNCIL (NEWBATTLE TERRACE AREA, EDINBURGH)
(REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE) ORDER
2024 - RSO/21/07

The City of Edinburgh Council, in exercise of the powers conferred on them by section 1(1) and 152 (2) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, hereby make the following Order:-

1. This Order may be cited as "The City of Edinburgh Council (Newbattle Terrace Area, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 2024" and shall come into operation on the Fifth day of August Two thousand and twenty-four.
2. The roads in the City of Edinburgh local government area specified in Schedule 1 to this Order, at present carriageway, shall become footway, the right of passage being exercisable foot only.

SCHEDULE 1

ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO FOOTWAY

Newbattle Terrace (North Side)

- a) All that part of the carriageway on the north side of Newbattle Terrace from the east kerbline of Morningside Road, eastwards for a distance of 11.9 metres or thereby and which has a width that varies from 0 metres or thereby to 2.4 metres or thereby and then 0.34 metres or thereby.
(marked as area N1 on the attached plans)
- b) All that part of the carriageway on the north side of Newbattle Terrace from a point 11.9 metres or thereby east of the east kerbline of Morningside Road, eastwards for a distance of 71.23 metres or thereby and which has a width that varies from 0.34 metres or thereby to 0.2 metres or thereby.
(marked as area N2 on the attached plans)
- c) All that part of the carriageway on the north side of Newbattle Terrace from a point 83.13 metres or thereby east of the east kerbline of Morningside Road, eastwards for a distance of 17.1 metres or thereby and which has a width that varies from 0.2 metres or thereby to 2.17 metres or thereby and then 0.2 metres or thereby.
(marked as area N3 on the attached plans)
- d) All that part of the carriageway on the north side of Newbattle Terrace from a point 100.23 metres or thereby east of the east kerbline of Morningside Road, eastwards for a distance of 66.82 metres or thereby and which has a width that varies from 0.2 metres or thereby to 1.34 metres or thereby.
(marked as area N4 on the attached plans)
- e) All that part of the carriageway on the north side of Newbattle Terrace from a point 167.05 metres or thereby east of the east kerbline of Morningside Road, eastwards for a distance of 16.95 metres or thereby and which has a width that varies from 1.34 metres or thereby to 3.45 metres or thereby and then 1.37 metres or thereby.
(marked as area N5 on the attached plans)
- f) All that part of the carriageway on the north side of Newbattle Terrace from a point 184 metres or thereby east of the east kerbline of Morningside Road, eastwards for a distance of 19.45 metres or thereby and which has a width that varies from 1.37 metres or thereby to 0.92 metres or thereby.
(marked as area N6 on the attached plans)
- g) All that part of the carriageway on the north side of Newbattle Terrace from a point 203.45 metres or thereby east of the east kerbline of Morningside Road, eastwards for a distance of 7.84 metres or thereby and which has a width that varies from 0.92 metres or thereby to 2.91 metres or thereby and then 0.77 metres or thereby.
(marked as area N7 on the attached plans)
- h) All that part of the carriageway on the north side of Newbattle Terrace from a point 211.29 metres or thereby east of the east kerbline of Morningside Road, eastwards for a distance of 35.89 metres or thereby and which has a width that varies from 0.77 metres or thereby to 0 metres or thereby.
(marked as area N8 on the attached plans)

- i) All that part of the carriageway on the north side of Newbattle Terrace and the west side of Pitsligo Road from a point 67.77 metres or thereby west of the west kerbline of Pitsligo Road, eastwards for a distance of 67.77 metres or thereby and then northwards for a distance of 9.24 metres or thereby and which has a width that varies from 0 metres or thereby to 0.38 metres or thereby and then 0 metres or thereby.
(marked as area N9 on the attached plans)
- j) All that part of the carriageway on the north side of Newbattle Terrace from a point 1.43 metres or thereby east of the east kerbline of Pitsligo Road, eastwards for a distance of 20 metres or thereby and which has a width that varies from 0 metres or thereby to 0.25 metres or thereby and then 0 metres or thereby.
(marked as area N10 on the attached plans)

Newbattle Terrace
(South Side)

- a) All that part of the carriageway on the south side of Newbattle Terrace from a point 14.56 metres or thereby east of the extended west building line of No. 2 Newbattle Terrace, eastwards for a distance of 15 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby and then 0 metres or thereby.
(marked as area S1 on the attached plans)
- b) All that part of the carriageway on the south side of Newbattle Terrace from a point 2.93 metres or thereby east of the extended east building line of Dominion Cinema, eastwards for a distance of 6.07 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby and then 0 metres or thereby.
(marked as area S2 on the attached plans)
- c) All that part of the carriageway on the south side of Newbattle Terrace from a point 19.88 metres or thereby east of the extended east building line of Dominion Cinema, eastwards for a distance of 6.19 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby and then 0 metres or thereby.
(marked as area S3 on the attached plans)
- d) All that part of the carriageway on the south side of Newbattle Terrace from a point 40.79 metres or thereby east of the extended east building line of Dominion Cinema, eastwards for a distance of 6.18 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby and then 0 metres or thereby.
(marked as area S4 on the attached plans)
- e) All that part of the carriageway on the south side of Newbattle Terrace from a point 11.45 metres or thereby west of the extended east building line of No. 42 Newbattle Terrace, eastwards for a distance of 12.64 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby and then 0 metres or thereby.
(marked as area S5 on the attached plans)
- f) All that part of the carriageway on the south side of Newbattle Terrace from a point 16.43 metres or thereby east of the extended west building line of No. 50 Newbattle Terrace, eastwards for a distance of 13.04 metres or thereby and which has a width that varies from 0 metres or thereby to 2 metres or thereby and then 0 metres or thereby.
(marked as area S5 on the attached plans)

- g) All that part of the carriageway on the south side of Newbattle Terrace and the west side of Falcon Gardens from a point 4.35 metres or thereby west of the extended east building line of No. 54 Newbattle Terrace, eastwards for a distance of 55 metres or thereby and then southwards to a point 2.25 metres or thereby north of the extended north building line of No. 68 Newbattle Terrace and which has a width that varies from 0 metres or thereby to 2 metres or thereby and then 0 metres or thereby.
(marked as area S7 on the attached plans)
- h) All that part of the carriageway on the south side of Newbattle Terrace and the east side of Falcon Gardens from a point 43.07 metres or thereby west of the extended west building line of No. 1 Eden Terrace, westwards for a distance of 38.31 metres or thereby and then southwards to a point 2.15 metres or thereby north of the extended north building line of No. 68 Newbattle Terrace and which has a width that varies from 0.77 metres or thereby to 3 metres or thereby and then 0 metres or thereby.
(marked as area S8 on the attached plans)
- i) All that part of the carriageway on the south side of Newbattle Terrace from a point 4.75 metres or thereby east of the extended west building line of No. 1 Eden Terrace, westwards for a distance of 47.82 metres or thereby and which has a width that varies from 0 metres or thereby to 0.95 metres or thereby and then 0.77 metres or thereby.
(marked as area S9 on the attached plans)
- j) All that part of the carriageway on the south side of Newbattle Terrace (Eden Terrace) and the west side of Eden Lane from a point 18.75 metres or thereby east of the extended west building line of No. 1 Eden Terrace, to a point 0.75 metres or thereby south of the extended north building line of No. 3 Eden Terrace and which has a width that varies from 0 metres or thereby to 0.37 metres or thereby and then 0 metres or thereby.
