### THE CITY OF EDINBURGH COUNCIL (NEWCRAIGHALL ROAD/NIDDRIE MAINS ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/146

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -


1. This Order may be cited as “The City of Edinburgh Council (Newcraighall Road/Niddrie Mains Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2024”. The order shall have effect on the Second day of September Two thousand and twenty-four and shall remain in force up to and including the Twentieth day of December Two thousand and twenty-four.
2. In this Order the following phrases have the meanings respectively assigned to them:  
“Article” means an Article of this Order;  
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;  
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;  
“the 2018 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and  
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate carriageway resurfacing and drainage improvement works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on: (i) **Blackchapel Close**, at its junction with Newcraighall Road; (ii) **Cleikiminfield**, at its junction with Newcraighall Road; (iii) **Cleikiminrig**, at its junction with Newcraighall Road; (iv) **Niddrie Marischal Road**, at its junction with Niddrie Mains Road; (v) **Niddrie Mill Avenue**, at its junction with Niddrie Mains Road; (vi) **Paterson Place**, at junction with Niddrie Mains Road; (vii) **Peacocktail Close**, at its junction with Newcraighall Road; and (viii) **Whitehill Road**, at its junction with Newcraighall Road; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of: (i) **Duddingston Park South**, from its junction with Niddrie Mains Road, northwards for a distance of 40 metres or thereby; (ii) **Newcraighall Road**, from its junction with Duddingston Park South/The Wisp, generally eastwards to the projected east property boundary of No. 60 Newcraighall Road; and (iii) **Niddrie Mains Road**, between its junction with Niddrie Marischal Road and its junction with Duddingston Park South/The Wisp.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
6. The alternative routes for through vehicular traffic will be by way of: (iv) **Niddrie Marischal Road** – Niddrie Marischal Road, Niddrie Marischal Crescent, Niddrie Marischal Place and Greendykes Road; (v) **Niddrie Mill Avenue** – Niddrie Mill Avenue, Niddrie Mill Drive, Niddrie Mill Place and Niddrie Mill Crescent; and (viii) **Whitehill Road** – Whitehill Road and Newcraighall Road.

7. The following roads have no available diversion, where local access will be maintained: (i) **Blackchapel Close**; (ii) **Cleikiminfield**; (iii) **Cleikiminrig**; (vi) **Paterson Place**; and (vii) **Peacocktail Close**.
