THE CITY OF EDINBURGH COUNCIL (PRODIGAL FATHER FILMING) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/164

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other enabling powers being satisfied that traffic on the lengths of roads specified in the Schedules hereto should be prohibited or restricted to facilitate the holding of Prodigal Father filming, and to enable members of the public to watch this event and being satisfied that it is not reasonably practicable for the event to be held otherwise than on a road and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, with the consent of the Scottish Ministers under sections 16B(1)(b) and 16B(6)(b) of the said Act, hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Prodigal Father Filming) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect during the hours and on the dates specified in the Schedules to this Order.
- 2. (a) In this Order the following phrases have the meaning respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "road" has the same meaning as in Section 151 of the 1984 Act and, for the avoidance of doubt, for the purposes of this Order, includes part of a road;
 - "Schedule" means a Schedule to this Order;
 - "the 2018 Order" means 'The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018'; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
 - (b) References in this Order to a disabled person, to a disabled person's badge, to a disabled person's vehicle and to a vehicle displaying a disabled person's badge in the relevant position shall be construed in accordance with the 1984 Act, The Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000 and The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 2002.
- 3. Save as provided in Article 4 of this Order, to facilitate the holding of Prodigal Father filming (as signed as affected by the event), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on any part of the lengths of roads specified in Schedule 1 hereto, where closures will apply to roads in their entirety unless otherwise stated;
 - (b) walk or cause or permit any person to walk on any of the lengths of footways specified in Schedule 2 hereto, where prohibitions will apply to footways in their entirety unless otherwise stated;
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on any part of the lengths of road specified in Schedule 3 hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated; and
 - (d) except with the permission of a Parking Attendant, cause or permit any vehicle to wait on the section of road described in Schedule 4 hereto.
- 4. Nothing in Article 3 shall apply to emergency service vehicles;

- 5. Nothing in Article 3(d) shall apply:
 - a. to motor vehicles being driven or used by disabled persons and which conspicuously display, so as to be clearly visible from the front of the vehicle, a valid disabled person's badge; and
 - b. so as to prevent any person from causing or permitting a vehicle to wait while the vehicle is in actual use for the purpose of delivering or collecting goods or while loading or unloading the vehicle at premises adjoining the said road; provided that:
 - (i) no such vehicle so engaged shall wait for a period of more than thirty minutes in the same place; and
 - (ii) no such vehicle so engaged shall return to the same place, unless a period of more than thirty minutes has elapsed since the termination of the previous waiting period.
- 6. The 2018 Order is hereby suspended in so far as it is affected by the restrictions specified in Articles 3(c) and (d) of this Order.
- 7. "The City of Edinburgh Council (Holyrood Road Area, Edinburgh) (Prohibition of Entry and Prohibition of Turning) and (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, and Parking Places) (Variation) Traffic Order 1999" will be suspended *between 12:00 hours on 13/09/2024 and 12:00 hours on 15/09/2024* in relation to the *prohibited right turn* from **Holyrood Road** into **St Mary's Street**, to allow general traffic to make the manoeuvre.
- 8. The alternative routes for through vehicular traffic with respect to the *closures* will be by way of: (1) **Niddry Street** High Street, St Mary's Street and Cowgate; (2) **St Giles' Street**, **Lawnmarket** and **High Street** Market Street, Bank Street and North Bank Street; and (3) **Canongate** and **Old Tolbooth Wynd** Horse Wynd, Queen's Drive, Holyrood Gait, Holyrood Road and St Mary's Street.
- 9. The following roads are not through roads and have no available diversion: **West Parliament Square** and **Bakehouse Close**.

- (i) **Canongate**, between its junction with New Street and its junction with Reid's Court; and (ii) **Old Tolbooth Wynd**, from its junction with Canongate, northwards for a distance of 20 metres or thereby.

- (D) from 07:00 hours to 20:00 hours on 14/09/2024 on:
- (i) **Canongate**: (1) *north side*, between its junction with Sibbald Walk and its junction with Lochend Close; and (2) *south side*, between its junction with Sugarhouse Close and its junction with Crichton's Close; (ii) **Old Tolbooth Wynd**, from its junction with Canongate, northwards for a distance of 20 metres or thereby; and (iii) **Cooper's Close**, from its junction with Canongate, southwards for a distance of 10 metres or thereby.

Johnston Terrace, *north side*, from Castle Wynd Steps North, south-westwards and north-eastwards for a distance of 85 metres or thereby and 65 metres or thereby respectively;

(I) from 08:30 hours on 09/09/2024 to 08:30 hours on 14/09/2024 on: **Mound Place**, *north side*, in its entirety;
