Introduction

The City of Edinburgh Council has a statutory duty under the Children and Young People (Scotland) Act 2014, to prepare and publish an Early Learning and Childcare (ELC) Delivery Plan which will detail the delivery of ELC across Edinburgh.

It is informed by, and builds on the biennial consultations held with parents and carers.

National Context

Since August 2021 all local authorities have been offering 1140 hours of funded ELC to all eligible two-year-olds and children who are three years old (the term after their third birthday) up to starting school age.

Flexibility and choice are fundamental to the ELC offer, and families can access high quality, funded ELC that meets their needs.

Local Context

The City of Edinburgh Council started planning for the delivery of 1140 funded hours of ELC in March 2017 and has fully supported the aims of delivering funded hours to help reduce the poverty related attainment gap and improve long term outcomes for children and families.



Our Vision, Value & Aims

Quality of Provision

- The local authority is the guarantor of quality ensuring that settings are meeting the National Standard as set out in "Funding follows the child and the National Standards for ELC providers"
- The City of Edinburgh Council is dedicated to delivering high quality education, including ELC for all children and young people, in partnership with parents and communities.
- A culture of continuous improvement underpins all activity and is the responsibility of all staff working within schools and early years settings and this is supported by our Quality Improvement team. Our shared goal is to enhance outcomes for all learners, ensuring children achieve and attain their potential.
- Improving quality is supported through effective self-evaluation, effective use of data and research, effective planning and innovative practice.

Quality of provision

The National Standard for Funded ELC outlines the requirements for providers to have Care Inspectorate quality evaluations of 'Good' or better across all themes. The Care Inspectorate evaluates the following:

- Quality of Care, Play and Learning
- Quality of Our Setting
- Quality of Our Leadership
- Quality of Our Staff Team

The information opposite outlines the quality of provision in Edinburgh

If a setting received Care Inspectorate evaluations below 'Good', or where any criteria from the ELC National Standards have not been met, the provider enters a Service Improvement Period (SIP) which is overseen by the local authority. Officers from the local authority provide continuous support and challenge to all providers to support quality delivery of ELC and offer advice and guidance when improvement is required.

The Importance of Play

Early learning and childcare providers should ensure that all children have play experiences as part of their daily lives, as enshrined in Article 31 (leisure, play and culture) of the UNCRC. To ensure consistency of high-quality experiences the City of Edinburgh Council have developed a Play and Learning framework to support all funded providers.



Care Inspectorate Quality Themes

Current Provision in Edinburgh – August 2024

Funded ELC is provided for approximately 11,000 children aged from 2 years to starting school age.

- Provision is available as follows:
- 102 local authority setting
- 7 local authority Forest Kindergartens
- 98 private, voluntary and independent sector settings
- 33 childminders

Edinburgh Council also provides discretionary ELC to children who are not eligible for funded hours. This includes places for:

- Two-year-olds who are homeless or living in temporary accommodation
- Two-year-olds who have been supported through the Family Nurse Partnership program
- Children under three years old on the Child Protection Register

Our delivery plan for 1140 funded hours was set up to maintain 65% of our provision in local authority settings 35% of provision in our partner settings. The full range of providers is available on Find early learning and childcare – The City of Edinburgh Council

The provision of ELC in Edinburgh is spread across the City and recorded within High School Learning Communities.



Provision cont'd

Parents can access their child's funded entitlement through the following delivery models in local authority settings:

- All day provision during term time, aligned with the school day 09:00 – 15:00
- 4hrs 30mins morning or afternoon, Monday to Friday, 50 weeks per year
- 10rs, Monday and Tuesday + Flexi Fridays or 10hrs Wednesday and Thursday + Flexi Fridays, 50 weeks per year

Provision cont'd

From August 2024, parents will have the option to purchase additional hours in settings open 50 weeks per year 08:00 to 18:00 (see table for costs)

Private, Voluntary or Independent providers who are in partnership with the City of Edinburgh Council to deliver funded ELC may offer these models or their own throughout the year.

Cross boundary places from August 2024 – parents from other local authorities who would like their child to have a funded place in Edinburgh will be able to access this in one of our local authority settings and places will be allocated in line with our admissions policy criteria.

Partnership with Parents and the Community

Research shows that when parents are engaged in their children's learning there are improved outcomes for children. Building strong partnership with parents and with the community that children live in, will continue to be a key focus for the Early Years Service. The national parenting strategy 2022 highlights the importance of communities *'helping parents to be the very best they can be to make a positive difference to children and young people'* Our evidenced based parenting programs in particular Peep LT, will continue to be developed to ensure this aim is sustained.

Our Key Themes for Developments 2024-2027

In line with statutory guidance, Edinburgh Early Years Service consults with families every two years to ensure their needs are reflected in service planning and delivery. Based on our consultation with parents/carers and our evaluation of the early year's expansion to 1140 hours, the key themes for development over the next 3 years will be:

- How we deliver Early Learning and Childcare?
- How we ensure Quality?
- How we support and develop our workforce?
- How we communicate, engage and consult?
