THE CITY OF EDINBURGH COUNCIL (LOCHEND ROAD AREA, LEITH) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/87

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Lochend Road Area, Leith) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect on the Thirtieth day of September Two thousand and twenty-four and shall remain in force up to and including the Fourteenth day of February Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate footway improvement works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on: (i) **Burns Street**, at its junction with Lochend Road; (ii) **Hermitage Park**, at its junction with Lochend Road; (iii) **Hermitage Park Grove**, at its junction with Lochend Road; (iv) **Lochend Road**, between its junction with Vanburgh Place and its junction with Hermitage Park Grove; (v) **Primrose Street**, at its junction with Lochend Road; (vi) **Restalrig Terrace**, at its junction with Lochend Road; and (vii) **Woodville Terrace**, at its junction with Lochend Road, provided that no more than one of the measures described in this section shall be enacted at any time; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on: (i) Burns Street, both sides, from its junction with Lochend Road, eastwards for a distance of 50 metres or thereby; (ii) Hermitage Park, both sides, from its junction with Lochend Road, eastwards for a distance of 50 metres or thereby; (iv) Lochend Road, both sides, between its junction with Vanburgh Place and its junction with Hermitage Park Grove; (v) Primrose Street, both sides, from its junction with Lochend Road, eastwards for a distance of 50 metres or thereby; (vi) Restalrig Terrace, both sides, from its junction with Lochend Road, eastwards for a distance of 50 metres or thereby; (vii) Vanburgh Place, south side, from its junction with Lochend Road, eastwards and south-westwards for a distance of 50 metres or thereby respectively; and (viii) Woodville Terrace, both sides, from its junction with Lochend Road, eastwards for a distance of 50 metres or thereby respectively; and (viii) Woodville Terrace, both sides, from its junction with Lochend Road, eastwards for a distance of 50 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

- 6. The alternative route for through vehicular traffic with respect to the *closure* of **Lochend Road** will be by way of Sleigh Drive, Restalrig Road South, Restalrig Road, East Hermitage Place, Hermitage Place and Vanburgh Place.
- 7. Local access will be maintained on the following roads: (i) **Burns Street**; (ii) **Hermitage Park**; (iii) **Hermitage Park Grove**; (iv) **Primrose Street**; (v) **Restalrig Terrace**; and (vi) **Woodville Terrace**.
